

### Qualifications

Shipping Cost Rebate Merchant Offer Details: To qualify for this rebate, a merchant must sign up for the Fulfilment by Amazon service before 30 June 2010, and the rebate earned will be based on only units shipped to and received at the appropriate Amazon fulfilment centre within 30 days or before 30 June 2010, of completing registration for FBA and accepting the terms of the online Seller Agreement for Fulfilment by Amazon.

## **How it Works**

- This offer applies to all shipments from a qualified merchant from 1 April 2010 through 30 June 2010.
- Qualified merchants will receive a one-time Merchant Shipping Rebate for the actual
  cost of their inbound shipments to an Amazon fulfilment centre up to the amount
  earned per the above schedule. The pound amount of any Merchant Shipping Rebate
  earned will be VAT inclusive and will be deposited to and/or used to offset any
  negative balance in the merchant's Amazon Seller account on or before 1 August
  2010. The rebate will be titled "Miscellaneous Adjustment."
- Qualified merchants will receive a one-time Merchant Fee Rebate to apply to the cost
  of Fulfilment by Amazon fees incurred through the merchant's Amazon Seller account
  between 1 April 2010 and 30 June 2010, for the amount earned per the above
  schedule. This pound amount will be VAT inclusive and deposited to and/or used to
  offset any negative balance in the merchant's Amazon Seller account on or before 1
  August, 2010.
- Qualified merchants will receive a single payment up to the amount earned per the above schedule and are limited to one Merchant Shipping Rebate and one Merchant Fee Rebate.
- This offer is not 'incremental'; merchants will not accumulate more than one Merchant Shipping Rebate or more than one Merchant Fee Rebate.
