1. The Lowest rate offered by the bidder for work should be on per ha. Basis.
2. The bid will not be accepted if proof of the bid fee and EMD are not enclosed.
3. The safety of the workers deployed for these works will be full responsibility of the bidder.
4. The child labour will not be allowed to work in this task.
5. The work should be started within 2-3 days from the receipt of the work order.
6. The seed production programme is a very essential programme of the university so the instructions of the higher authorities and Farm Incharge should be followed strictly.

TERMS & CONDITIONS:

1. Bid Preparation and Submission:

- 1.1 The bid/quotation must be submitted on official letter head of the bidder in the enclosed format (Annexure-1) and signed by the Bidder and must be properly sealed in an envelope. On the envelope "Bid for the Supply of [Name of Item/Services.]", "Due date of Opening" and Bid Ref. No. must be clearly marked. If the bid is not sealed and marked as required, the Procuring Entity shall assume no responsibility about its consequences including misplacement and premature opening of the Bid.

2. Validity of Quotation:

- 2.1 Quotation shall remain valid for acceptance for a period of four months.

3. Bid price

All taxes like Central/ Rajasthan Sales Tax/ VAT, Service Tax, etc. to be charged extra and bidder will be liable.

3.1 Award of Contract/Supply Order

4. The bidder whose quotation has been determined to be substantially responsive, conform to the terms & conditions, and specifications and who has offered the highest

evaluated quotation price.

4.1 Notwithstanding the above, the college reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.

5. Number of vilayati babul plants are approximately 600 and final number of trees will be on actual basis

5.1 The bids will not be accepted without Bid security money of RS. 15000/- Fifteen thousand.

5.2 In all future references the Bid No. must be invariably mentioned.

5.3 The bidder has to mention their RST/CST/VAT/TIN /PAN No. in their quotations otherwise their bids are liable to be rejected.

Terms of Payment

The payment will be made in 4 instalments after verification of bill from concerned unit incharge and I. Tax will be deducted as per rules.

1. Ist bill will be paid after completion of pre sowing irrigation, sowing, spray of herbicide,

Ist dose of urea, Ist, 2nd irrigation etc.15% of approved amount.

2.. IInd bill will be paid after completion of 3rd, 4th, 5th, 6th, irrigation , weeding etc. 15%.

3. IIIrd bill will be paid after completion of 7,8,9,10th irrigation and picking of pods etc. 30%.

4.IVth bill will be paid after completion of 11,12th irrigation, harvesting, threshing, cleaning and weighing of row seed and storage in godown etc. 40%.

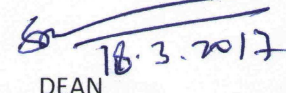
5.The above slabs of the payment are not reflecting the quantum of work in the ratio of payment.



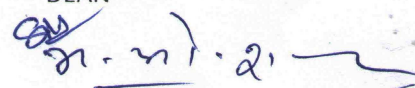
