of the University. Authorized the Vice-Chancellor for taking further action on the opinion given by the Legal Counsel.

(b) Those cases which are fresh cases and are covered under the provisions of UGC Regulations, 2000, the CAS benefit is to be given from the date of eligibility, for the same meetings for promotion under Career Advancement Scheme be convened at an early date.

4. At Resolution NO. MPUAT/BOM-42/2015-03/06 it was also *RESOLVED* that the seniority list published in consonance with the provisions under UGC Regulations, 2010 was approved with the observations that:

(a) The University must initiate steps so as to make the UGC 2010 Regulations as a part of Statutes of the University to avoid any legal complications.

(b) Issue a 'Notification' quoting the reason for adopting the provisions of UGC Regulations 2010 for determining the seniority.

5. At Resolution NO. MPUAT/BOM-42/2015-03/09 it was also RESOLVED that first of all University must ensure that optimum utilization of land available with the University is taken and thereafter taking with full facts, figures and justification, a letter may be written to Government for allotment of land.

While discussion Dr. V.B. Singh, Hon'ble Member enquired whether or not a Scholar Register for students and Employee Register for all the employees is maintained at University level. After discussion at length it was RESOLVED that (a) the University will initiate immediate steps to maintain an Employee Register at University level and (b) the data related to establishment be filled up within a month in the existing digitalization software - Integrated University Management System so that the concerned can get access to his / her details easily.
