To report the action taken on the minutes of the last meeting of Board of Management, held on 11th February, 2015.

To approve the recommendations of the Academic Council, meeting held on 10th February, 2015.

RESOLVED to approve the recommendations of the Academic Council, meeting held on 10<sup>th</sup> February, 2015. However, Dr. V.B. Singh, Eminent Educationist / Scientist took a note of dissent on the Resolution No. MPUAT/AC-43/2015-01/03 in the matter of counting of services for experience purpose under CAS. But in view of the provisions of MPUAT Act, approving considering and for recommendations of Academic Council, the matter was approved.

It was also desired that while discussing Resolution No. MPUAT/AC-43/2015-01/05 that the Director Extension Education may be advised to submit proposals to Divisional Commissioner & Ex-Officio Commissioner, TAD for skill development of tribal

belt at an early date.

## MPUAT/BOM-41/ 2015-02/04

With reference to Resolution No. MPUAT/BoM-40/2015-01/06 of the meeting of Board of Management, held on 11th February, 2015, to submit the case of Dr. N.K. Punjabi, Professor, Department of Extension Education, RCA, Udaipur and Dr. A.S. Solanki, Professor (Retd.) regarding waiving the condition of contributing 20% of the total emoluments for the total salary, they drawn abroad, during the period of their Leave without Pay for perusal only.

The matter was perused by the Members of Board of Management. Members were of the opinion to reconsider the case of Dr. Punjabi, however, it was informed to the house that in pursuance to the decision of Board of Management, meeting held on 20.01.2007, vide Resolution No. MPUAT/BOM-18/2007-01/02 Dr. Punjabi has submitted the duly signed 'Undertaking' before proceeding abroad that he will contribute 20% of the total emoluments he will earn abroad to the University, therefore as financial aspect is involved in the matter, hence, it was resolved that the matter be referred to the Government for waving the condition of contributing 20% of total emoluments drawn by Dr. N.K. Punjabi abroad for the period of Leave without Pay to serve as "Expatriate Staff" at Harmaya University, Ethiopia.

#### MPUAT/BOM-41/ 2015-02/05

To consider giving relaxation with regard to minimum prescribed period and experience for considering promotions on various non-teaching positions.

RESOLVED to approve for giving relaxation in experience only to the non-teaching staff of the University, as per latest orders of Government, with the condition that such relaxation can be given to a maximum of one third period only and also that the same be implemented in the University after getting permission from the State Government.

#### MPUAT/BOM-41/ 2015-02/06

To report the Order No. F. MPUAT/Estt/Gr. I/2015/1345-59 dated 23rd March, 2015, adopting the Government order for appointment as Probationer instead of Probationer Trainee on the posts of Professor and Associate Professor in the University and also giving pay to such appointees as per FD Notification No. F.12(6)FD/Rules/2005 dated 23.09.2014.

RESOLVED to note the same.



## MPUAT/BOM-41/ 2015-02/07

To consider nomination of one person on the Selection Constitute, constituted for recommending the name of new Vice-Chancellor to be appointed in the University.

Dr. Dilip Goyal, Jt. Secretary, Hr. Education proposed the name of Dr. R.C. Verma, Ex-Professor & Head, Agriculture Economics, SKNCOA, Jobner and only four members out of eight members, who were having voting right, were agreeing to this proposal. Thereafter the Vice-Chancellor & Chairman proposed that looking towards the importance of the issue, the nominated person should not be below Director / Ex-Director, Dy. Director / Ex-Dy. Director, Vice-Chancellor / Ex-Vice-Chancellor, Dean / Ex-Dean of ICAR, SAUs. But as the common consensus could not be arrived, hence the matter was deferred (detailed enclosure annexed).
