

## **Data Processing Consent Form**

(hereinafter the **Company**), as well as to any entity delegated by the Company to process Personal Data for purposes indicated in article 8 and 9. Company may process Personal Data for the following purposes:

- Creating Customer's account;
- 2. Rendering communications and hosting services;
- 3. Identifying Customer on Customer's account page for rendering Services;
- 4. Providing information about the Company, our services, and events;
- 5. Communicating with you when you contact us;
- 6. Exercising authority and performing all obligations imposed upon the Company by Russian law;
- Sending our news and update information;
- 8. Complying with Company access regulations: verifying your identity when entering the Company premises; ensuring personal safety to all Company employees and the integrity of all materials and valuables in the Company's care; and identifying and investigating incidents occurring on Company's territory;
- 9. Processing bankcard payments to the Company.

The Data Processing Agreement for purposes indicated in points 1-7 and 9 shall remain in effect until the purposes for processing Personal Data are accomplished or in the event of frustration of purpose and the deletion of your account on the corresponding website or a withdrawal of consent, and for the purpose indicated in point 8 for a period of 3 years.
