As discussed, data subjects have means to directly contact Google regarding the rights under the Serbian Law on Personal Data Protection (“Official Gazette of the Republic of Serbia”, No. 87/2018; hereinafter called as “the Serbian Data Protection Law”) through the [Google Privacy Help Centre](#) where users can find webforms including the [Data Access Request Form](#) [<https://support.google.com/policies/contact/sar?hl=sr>] or the [Privacy Inquiry Form](#) [https://support.google.com/policies/contact/general_privacy_form]. The [Google Privacy Help Centre](#) also allows the data subjects to manage their privacy, check what data Google collects and uses, and find answers to many common questions about privacy and user data related to Google’s products and services. [The Privacy Help Centre](#) is accessible from our [Privacy Policy](#) [<https://policies.google.com/privacy?hl=sr>].

Additionally, Google LLC has now also appointed BDK Advokati to act as its local representative under Article 44 of the Serbian Data Protection Law. BDK Advokati address is Bulevar kralja Aleksandra 28, 11000 Belgrade.
