Main factors of man-made emergencies



- Growth of density and number of population in large populated areas, migration to megalopolises
- Significant wear of basic production assets, often untimely maintenances and renewal

- Production processes located in vicinity to populated areas
- Technologies not always complying with modern safety requirements
- Sharp growth of number of vehicles and insufficient amount of needed infrastructure and traffic flow controls






Emergencies in CIS States in 2014

- 11 Member States
- 282 million people
- 22 million square km



- Over 50 000 emergencies, including 170 industrial accidents
- 2 954 killed





Agreements and legal framework of cooperation in issues of prevention and mitigation of natural and man-made emergencies

- Agreement on cooperation in the field of prevention and mitigation of consequences of natural and man-made emergencies
- Agreement on cooperation in the field of industrial safety assurance in hazardous production facilities
- Agreement on mutual assistance in case of accidents and other emergencies in electrical engineering facilities of the CIS member states
- Agreement on exchange of information on natural and man-made emergencies
- Agreement on control of transboundary transport of hazardous and other waste
- Agreement on cooperation in the field of environment protection of the CIS member states
- Procedure of arranging cooperation between the CIS member states when mitigating consequences of natural and man-made emergencies





Enhancing agreements and legal framework of cooperation in issues of prevention and mitigation of natural and man-made emergencies

October 16, 2015 – session of the Council of the leaders of the CIS states

Adopted:

- **new Agreement on cooperation between the CIS member states in the field of prevention and mitigation of emergencies** – *updated procedure of mutual notification about emergencies and joint response to them within the CIS*
- **Address in connection with the 30th anniversary of the Chernobyl accident** (*one of the biggest man-made disasters*)





Cooperation in prevention and mitigation of man-made emergencies

- **Interstate Council for Industrial Safety** – *process and production safety, state of production assets*
- **Interstate Council for Natural and Man-made Emergencies** – *arranging the system of emergency assistance to CIS states in case of emergencies in their territories*





Interstate Council for Industrial Safety

Established – *September 28, 2001*

Participants – *Armenia, Azerbaijan, Belarus, Kazakhstan, Kyrgyzstan, Moldova, Russia, Tajikistan, Ukraine*

Members – *leaders of state supervisory authorities implementing state policies in the field of industrial safety of the CIS member states*





Main areas of activities of Interstate Council for Industrial Safety

- Making common principles and procedures of mutual recognition of permits for application of technical devices in hazardous production facilities
- Mutual recognition of accreditations and procedures used to confirm compliance with industrial safety requirements
- Agreement of principles of mutual recognition of licenses to types of activities in the field of industrial safety
- Setting common requirements to training and certification of staff of organizations operating hazardous production facilities





Action plans to implement Agreement on cooperation in the field of industrial safety assurance in hazardous production facilities

- Workshops and conferences on most topical issues of industrial safety and supervisory activities
- Joint inspections in complex hazardous production facilities



- Sharing experience in different areas of control and supervisory activities
