RE: NOTICE OF TERMINATION OF REGISTRAR ACCREDITATION AGREEMENT

Dear Mr. Chambers,

Please be advised that R. Lee Chambers Company LLC dba DomainsToBeSeen.com's ("DomainsToBeSeen.com") Registrar Accreditation Agreement ("RAA") with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 5 March 2008 ("RAA") is terminated pursuant to Section 5.3.4 of the RAA. The termination shall become effective 13 March 2013, 30 days from the date of this notice.

The termination is due to DomainsToBeSeen.com's failure to timely cure the breaches by 1 February 2013 as set forth in ICANN's notice of breach of RAA dated 11 January 2013 http://www.icann.org/en/news/correspondence/serad-to-chambers-11jan13-en.pdf. As of 11 February 2013, the following breaches remain:

 Failure to maintain records relating to DomainsToBeSeen.com's dealings with Registry Operator(s) and Registered Name Holders and to make such records available to ICANN for inspection, pursuant to Sections 3.4.2 and 3.4.3 of the RAA.

Please see the chronology below for additional details.

DomainsToBeSeen.com is further advised that the logo license Appendix to the RAA is revoked as of 13 March 2013. Please remove all ICANN trademarks, name and logo from DomainsToBeSeen.com's website and business materials that have been licensed to DomainsToBeSeen.com under the terms of that Appendix by 13 March 2013. In addition, please pay the outstanding accreditation fees totaling \$1,178.12 immediately.

Domain Name Transition Process

To protect domain name registrants, ICANN will commence the domain name transition process and will solicit bids for a qualified ICANN-accredited registrar to manage the domain names currently managed by DomainsToBeSeen.com.

ICANN will follow the De-Accredited Registrar Transition Procedure ("Procedure") http://www.icann.org/en/processes/registrars/de-accredited-registrar-transition-procedure-01oct08.pdf. Consistent with the Procedure, please designate a bulk transfer recipient by 15 February 2013 and inform ICANN's Registrar Liaison Team at RegTransition@icann.org.

ICANN reserves all its rights under the RAA. Please note the rights and obligations required to have effect after the expiration of the RAA, including but not limited to Sections 3.4 Retention of Registered Name Holder and Registration Data, 3.9 Accreditation Fees, 5.6 Resolution of Disputes Under this Agreement and 5.7 limitations on Monetary Remedies for Violations of this Agreement.
