**RE: NOTICE OF BREACH OF REGISTRAR ACCREDITATION AGREEMENT**

Dear Mr. Torres,

Please be advised that as of 30 August 2013, Locaweb Servicos de Internet S/A dba Locaweb ("Locaweb") is in breach of its Registrar Accreditation Agreement ("RAA") with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 6 March 2011. This breach results from:

- Failure to notify ICANN, within 30 days, of any change to its contact information pursuant to Section 5.11 RAA;

ICANN requests that Locaweb cure this breach by 23 September 2013, 15 working days from the date of this letter, by taking the following action:

1. Update Locaweb's contact information in RADAR.

If Locaweb fails to timely cure this breach and provide the information requested by 23 September 2013, ICANN may commence the RAA termination process.

## ATTACHMENT

### Failure to Update Contact Information

Section 5.11 of the RAA requires Locaweb to notify ICANN within 30 days of any change to its contact information. Since 21 June 2013, after identifying that Locaweb's contact information in RADAR was incorrect, ICANN contacted Locaweb several times via email, telephone and fax requesting that the registrar update its contact information. To date, Locaweb has not responded to these requests and has not updated RADAR.

Locaweb's repeated failure to provide ICANN with the updated contact information constitutes a breach of Section 5.11 of the RAA.
