**RE: NOTICE OF TERMINATION OF REGISTRAR ACCREDITATION AGREEMENT**

Dear Mr. Wall,

Please be advised that Bargin Register, Inc.'s ("Bargin") Registrar Accreditation Agreement ("RAA") with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 23 March 2011 ("RAA") is terminated pursuant to Section 5.3.4 of the RAA. The termination shall become effective 22 March 2013, 30 days from the date of this notice.

The termination is due to Bargin's failure to timely cure breaches set forth in ICANN's notice of breach of RAA dated 19 November 2012 by 10 January 2013, the second extended cure date granted by ICANN. For details, go to: <http://www.icann.org/en/resources/compliance/notices>

As of 20 February 2013, the following breaches remain:

1. Bargin's failure to maintain registration data and records concerning the domain name <rexrothdistributors.com> pursuant to Section 3.4.2 of the RAA; and
2. Bargin's failure to make registration data and records available to ICANN upon reasonable notice, pursuant to Section 3.4.3 of the RAA.

#### Domain Name Transition Process
