**RE: NOTICE OF BREACH OF REGISTRAR ACCREDITATION AGREEMENT**

Dear Mr. Nelson,

Please be advised that as of 30 January 2015, Domain Jamboree, LLC (“Domain Jamboree”) is in breach of its Registrar Accreditation Agreement (“RAA”) with the Internet Corporation for Assigned Names and Numbers (“ICANN”) dated 23 February 2010 (“RAA”). These breaches result from:

1. Domain Jamboree’s failure to notify ICANN within 30 days of an entity’s acquisition of a controlling interest in Domain Jamboree’s stock, assets or business, as required by Section 5.9.2 of the RAA;
2. Domain Jamboree’s failure to notify ICANN of a change to its contact information within thirty (30) days, as required by Section 5.11 of the RAA; and
3. Domain Jamboree’s failure to timely pay past due accreditation fees in the amount of \$2,662.14, as required by Section 3.9 of the RAA.

Additional Considerations

In addition, during the processing of this complaint, ICANN received information that suggests Domain Jamboree may have been placed into receivership. Questions regarding Domain Jamboree's good standing and Domain Jamboree's failure to provide a current registrar contact caused delays during the processing of this complaint.

ICANN requests that Domain Jamboree cure the breaches by 20 February 2015, 15 business days from the date of this letter, by taking the following actions:

1. Complete the process for Purchasing an ICANN-Accredited Registrar (available online at <https://www.icann.org/resources/pages/purchasing-2013-07-08-en>);
2. Provide ICANN with written notification of updated contact information in accordance with Section 5.11 of the RAA;
3. Provide ICANN with documentation that Domain Jamboree is in good standing in its jurisdiction of incorporation and is not bankrupt or insolvent; and
4. Pay all past due accreditation fees of \$2,662.14.

If Domain Jamboree fails to timely cure the breaches by 20 February 2015, ICANN may commence the RAA termination process.

## ATTACHMENT

### Failure to Notify ICANN of Assignment, Change of Ownership or Management.

Section 5.9.2 of the RAA requires, to the extent that an entity acquires a controlling interest in a registrar's stock, assets or business, a registrar must provide ICANN notice within thirty (30) days of such an acquisition. Such notification must include a statement that affirms that a registrar meets the ICANN-adopted specification or policy on accreditation criteria then in effect, and is in compliance with its obligations under the RAA. Domain Jamboree's failure to provide ICANN with notification of a change in its controlling interest is a breach of Section 5.9.2 of the RAA.

### Failure to notify ICANN of changes to its contact information

Section 5.11 of the RAA requires registrars to provide written notification to ICANN within thirty (30) days of any change to its contact information. Domain Jamboree's failure to provide ICANN with written notice of changes to its contact information is a breach of Section 5.11 of the RAA.

### Failure to pay accreditation fees

Section 3.9 of the RAA requires registrars to timely pay accreditation fees to ICANN, consisting of yearly and variable fees. Domain Jamboree owes ICANN \$2,662.14 in past due accreditation fees, in breach of Section 3.9 of the RAA.
