**RE: NOTICE OF TERMINATION OF ACCREDITATION AGREEMENT**

Dear Mr. Wettstein,

Please be advised that as of 26 August 2014, documentdata Anstalt's ("documentdata Anstalt") Registrar Accreditation Agreement ("RAA") with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 1 February 2014 ("RAA") is terminated pursuant to Section 5.5.4 of the RAA. The termination shall become effective 25 September 2014, 30 days from the date of this notice.

The termination is due to documentdata Anstalt's failure to timely cure the breaches by 13 August 2014 as set forth in ICANN's notice of breach of RAA dated 23 July 2014. As of 26 August 2014, the following breaches remain:

1. Failure to maintain and make available to ICANN registration records relating to dealings with Registered Name Holder ("RNH") of the domain name <maramonesse.com>, pursuant to Sections 3.4.2 and 3.4.3 of the RAA;
2. Failure to allow the RNH of the domain name <maramonesse.com> to transfer its domain name registration to another registrar, pursuant to Section 1 of the Inter-Registrar Transfer Policy ("IRTP"), or, alternatively, provide a valid reason for denial, pursuant to Section 3 of the IRTP;

3. Failure to provide a AuthInfo code within five calendar days of a request to the RNH for the domain name <maramonesse.com>, pursuant to Section 5 of the IRTP;
4. Failure to provide domain name data in the specified response format, as required by Section 1.4 of the Registration Data Directory Service (Whois) Specification of the RAA ("Whois Specification");
5. Failure to provide a description on documentdata Anstalt's website of renewal fees, post-expiration renewal fees (if different) and redemption/restore fees, as required by Section 4.1 of the Expired Registration Recovery Policy ("ERRP");
6. Failure to send renewal reminder notices at least one month prior to expiration and at least one week prior to expiration, as required by Section 2.1 of the ERRP; and
7. Failure to pay past due accreditation fees, pursuant to Section 3.9 of the RAA.

Please see the chronology below for additional details.

documentdata Anstalt is further advised that the logo license granted in the Logo License Specification to the RAA is revoked as of 25 September 2014. Please remove all ICANN trademarks, name and logo from documentdata Anstalt's website and business materials that have been licensed to documentdata Anstalt under the terms of that specification by 25 September 2014.

#### Domain Name Transition Process

To protect domain name registrants, ICANN will commence the domain name transition process and will solicit bids for a qualified ICANN-accredited registrar to manage the domain names currently managed by documentdata Anstalt.

ICANN will follow the [De-Accredited Registrar Transition Procedure](#) ("Procedure"). Consistent with the Procedure, please designate a bulk transfer recipient by 2 September 2014 and inform ICANN's Registrar Liaison Team at [RegTransition@icann.org](mailto:RegTransition@icann.org).

ICANN reserves all its rights under the RAA. Please note the rights and obligations required to have effect after the expiration of the RAA, including but not limited to, Sections 3.4 Retention of Registered Name Holder and Registration Data, 3.9 Accreditation Fees, 5.8 Resolution of Disputes Under this Agreement and 5.9 limitations on Monetary Remedies for Violations of this Agreement.
