EPDP on the Temporary Specification for gTLD Registration Data Update for Week of 27 August 2018

WHAT HAPPENED THIS WEEK?

- Based on EPDP member comments and subsequent discussion, the Support Staff will be updating the triage report to include SO/AC/SG/C comments only.
- The EPDP Team began working through the substance of the Temporary Specification in the order detailed in the [Project Plan](#). Going forward, each meeting will be divided into two topics for discussion.
- This week, the EPDP Team began deliberating [§ 4.4](#) (Legitimate Purposes for Processing) and [Appendix C](#) (Data Processing Requirements) of the Temporary Specification.
- The Team tentatively agreed to bifurcate the purposes found in [§ 4.4](#) between:
 - (1) Registrar-Registry-ICANN Contract Purposes (for collection), which includes 4.4.1, 4.4.3, 4.4.4, 4.4.5, 4.4.6, 4.4.7, 4.4.11, 4.4.12, and 4.4.13; and
 - (2) Third Party legitimate interests (for access), which includes 4.4.2, 4.4.8, 4.4.9, and 4.4.10.
- Some of the contracted parties indicated the purposes listed in [§ 4.4](#) do not align with current data collection processes and the domain name lifecycle. As such, registrars have volunteered to redraft the language and share the updated text with the Team for further review next week.
- Additionally, the Team noted issues with the third party legitimate interests, and small teams lead by EPDP Team Member volunteers will work on redrafting the third party legitimate interests (to be shared next week).
- The Team began deliberating on [Appendix C](#), and deliberations will continue at the next meeting, Tuesday, 4 September 2018.
- In response to EPDP member feedback, Support Staff is looking into a GDPR training course, including options suggested by EPDP Team members, that all EPDP Team members will be required to take.

WHAT IS ON NEXT WEEK'S AGENDA?

- The Team will continue deliberating on [§ 4.4](#) (Legitimate Purposes for Processing) and [Appendix C](#) (Data Processing Requirements), using the aforementioned redrafted language.
- During the meeting on Thursday, 6 September, the Team will continue to deliberate on [Appendix C](#) (Data Processing Requirements) and [Appendix A](#) (Registration Data Directory Services).

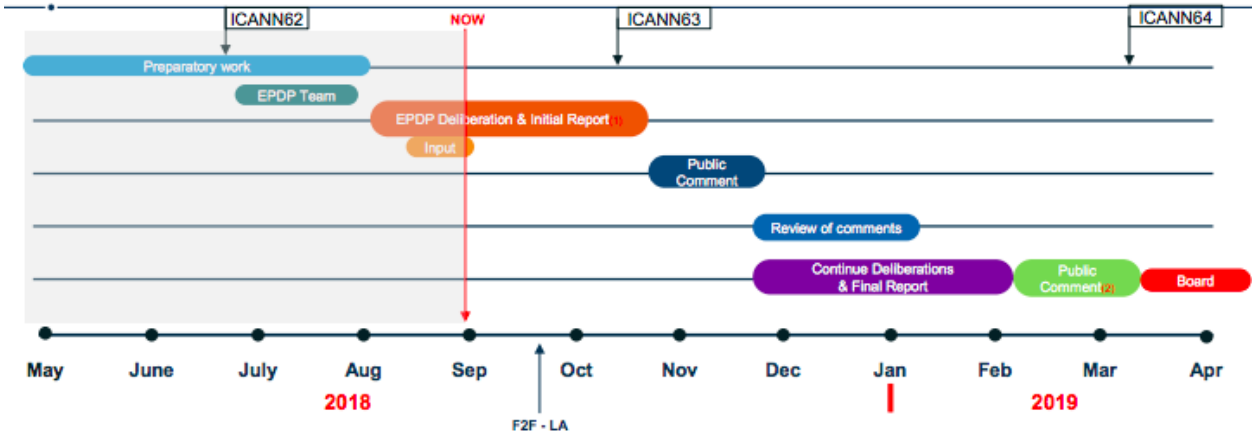
