**RE: NOTICE OF BREACH OF REGISTRAR ACCREDITATION AGREEMENT**

Dear Mr. Jeske,

Please be advised that as of 18 January 2013, Cheapies.com Inc. ("Cheapies.com") is in breach of its Registrar Accreditation Agreement ("RAA") with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 15 February 2011 ("RAA"). These breaches result from:

1. Cheapies.com's failure to make available to ICANN copies of any written communications between Cheapies.com and the Registered Name Holders concerning the domain names <xinglongxing.com>, <xlxmail.com>, <mailxlx.com>, and <royalcitycommunitychurch.org>, pursuant to Section 3.4.3 of the RAA;
2. Cheapies.com's failure to provide the Registered Name Holder a reasonable opportunity and ability to unlock the domain names <xinglongxing.com>, <xlxmail.com>, and <mailxlx.com> prior to the Transfer Request, as required by Section 3 of the Inter-Registrar Transfer Policy ("IRTP"); and

3. Cheapies.com's failure to provide the Registered Name Holder the "AuthInfo" code within 5 calendar days concerning the domain name <royalcitycommunitychurch.org>, as required by Section 5 of the IRTF.

Please refer to the attachment for details regarding these breaches.

#### Additional Considerations

ICANN notes that Cheapies.com received a Notice of Breach from ICANN dated 11 January 2013 regarding the failure of Cheapies.com to timely respond to audit notices and to timely pay accreditation fees. To date, Cheapies.com has not contacted ICANN Contractual Compliance regarding that Notice. The facsimile and courier copies of the 11 January 2013 Notice sent to the Primary Contact for Cheapies.com (as listed in RADAR) were undeliverable.

ICANN requests that Cheapies.com cure the breaches by 8 February 2013, 15 working days from the date of this letter, by taking the following actions:

1. Provide copies of all written communications between Cheapies.com and the Registered Name Holders, including a copy of the registration agreement entered between Cheapies.com and the Registered Name Holders; and records of the account of the Registered Name Holders with Cheapies.com for the domain names <xinglongxing.com>, <xlxmail.com>, <mailxlx.com>, and <royalcitycommunitychurch.org> pursuant to Section 3.4.3 of the RAA;
2. Unlock (or provide the Registered Name Holder the ability to unlock) the domain names <xinglongxing.com>, <xlxmail.com>, and <mailxlx.com>;
3. Provide the Registered Name Holder the "Authinfo" code for <royalcitycommunitychurch.org>; and
4. Provide ICANN with documentation sufficient to demonstrate Cheapies.com has made reasonable efforts to inform Registered Name Holders of, and provide access to, the published documentation of the specific transfer process employed by Cheapies.com.

5. Provide ICANN with a primary contact update form duly completed and signed.

If Cheapies.com fails to timely cure the breaches and provide the information requested, ICANN may commence the termination process.

## ATTACHMENT

### Failure to Make Records Relating to Registered Name Holders Available to ICANN

Section 3.4.2 of the RAA requires Cheapies.com to maintain registration data and records relating to its dealings with Registered Name Holders and with the Registry Operator(s) for every domain name under Cheapies.com's management. Section 3.4.3 of the RAA requires Cheapies.com to make these records and data available to ICANN upon reasonable notice.

As detailed in the chronology below, ICANN sent four notices to Cheapies.com requesting registration data and records for the domains <xinglongxing.com>, <xlxmail.com>, and <mailxlx.com>; and sent three notices to Cheapies.com requesting registration data and records for the domain <royalcitycommunitychurch.org>. To date, Cheapies.com has not provided these documents.

### Failure to Unlock Domain Name or Allow Registered Name Holder to Unlock Domain Name

Section 3 of the IRTP provides that a registrar may not deny a requested change of registrar of a domain name in Registrar Lock Status, unless the Registered Name Holder is provided with the reasonable opportunity and ability to unlock the domain name prior to the Transfer Request.

As detailed in the chronology below, ICANN requested that Cheapies.com confirm that it provided the RNH with reasonable opportunity to unlock the domain names. To date, Cheapies.com has not responded to this request.



### Failure to Provide "AuthInfo" Code to Registered Name Holder Within Five Calendar Days

Section 5 of the IRTP requires that a registrar must provide the Registered Name Holder with the unique "AuthInfo" code within five (5) calendar days of the Registered Name Holder's initial request if the Registrar does not provide facilities for the Registered Name Holder to generate and manage their own unique "AuthInfo" code.

As detailed in the chronology below, ICANN requested that Cheapies.com provide documentation regarding the "AuthInfo" code for the domain <royalcitycommunitychurch.org>. To date, Cheapies.com has not provided these documents.
