RE: NOTICE OF BREACH OF REGISTRAR ACCREDITATION AGREEMENT

Dear Ms. Yu,

Please be advised that as of 11 March 2015, Verelink, Inc. (“Verelink”) is in breach of its Registrar Accreditation Agreement (“RAA”) with the Internet Corporation for Assigned Names and Numbers (“ICANN”) dated 31 March 2013 (“RAA”). This breach results from:

1. Verelink’s failure to timely pay past due accreditation fees in the amount of \$2,607.85, as required by Section 3.9 of the RAA.

Please refer to the attachment for details regarding this breach.

ICANN requests that Verelink cure these breaches by 1 April 2015, 15 business days from the date of this letter, by taking the following action:

1. Pay all past due accreditation fees of \$2,607.85.

If Verelink fails to timely cure the breach by 1 April 2015, ICANN may commence the RAA termination process.

Failure to pay accreditation fees

Section 3.9 of the RAA requires registrars to timely pay accreditation fees to ICANN, consisting of yearly and variable fees. Verelink owes ICANN \$2,607.85 in past due accreditation fees, in breach of Section 3.9 of the RAA.
