Dear Sui Xin,

Please be advised that as of 13 November 2017, Hezhong Liancheng Beijing Technology Co., Ltd (“Hezhong”) is in breach of its 2013 Registrar Accreditation Agreement with the Internet Corporation for Assigned Names and Numbers (“ICANN”) dated 2 July 2015 (“RAA”). This breach results from:

1. Hezhong’s failure to timely pay past due accreditation fees, as required by Section 3.9 of the RAA.

Hezhong’s contact information, including its telephone and facsimile numbers, is invalid.

ICANN requests that Hezhong cure this breach by 4 December 2017, 21 days from the date of this letter, by taking the following actions:

1. Pay all past and currently due accreditation fees; and
2. Provide ICANN with corrective and preventative action(s), including implementation date(s), to ensure that:
 - a. Hezhong will timely make payments and respond to ICANN compliance matters; and
 - b. Hezhong’s contacts with ICANN are valid and up to date.

If Hezhong fails to timely cure the breaches and provide the information requested by 4 December 2017, ICANN may commence the RAA termination process.

Failure to pay accreditation fees

Section 3.9 of the RAA requires registrars to timely pay accreditation fees to ICANN, consisting of yearly and variable fees. Hezhong owes ICANN past due accreditation fees, in breach of Section 3.9 of the RAA. Hezhong additionally owes currently due accreditation fees, due 14 and 30 November 2017.
