RE: NOTICE OF TERMINATION OF ACCREDITATION AGREEMENT

Dear Mr. Ramirez,

Please be advised that as of 22 June 2016, MOBILE.CO DOMAINS CORP.'s ("Mobile.co") Registrar Accreditation Agreement ("RAA") with the Internet Corporation for Assigned Names and Numbers ("ICANN") dated 30 July 2015 ("RAA") is terminated pursuant to Section 5.5.4 of the RAA. The termination shall become effective 21 July 2016, 30 calendar days from the date of this notice. ICANN extends Mobile.co's current suspension to align with the termination effective date.

The termination is due to Mobile.co's failure to timely cure the breaches by 23 February 2016 as set forth in ICANN's Notice of Breach of RAA dated 2 February 2016. As of 22 June 2016, the following breaches remain:

1. Mobile.co's failure to escrow gTLD registration data, as required by Section 3.6 of the RAA;
2. Mobile.co's failure to provide an interactive webpage and a port 43 Whois service providing free public query-based access to up-to-date data concerning all active registered names sponsored by Mobile.co for each top-level domain ("TLD") in which it is accredited, as required by Section 3.3.1 of the RAA; and

3. Mobile.co's failure to timely pay past due accreditation fees, as required by Section 3.9 of the RAA.

Mobile.co is further advised that the logo license granted in the Logo License Specification to the RAA is revoked as of 21 July 2016. Please remove all ICANN trademarks, name and logo from Mobile.co's website and business materials that have been licensed to Mobile.co under the terms of that Specification by 21 July 2016.

Domain Name Transition Process

To protect domain name registrants, ICANN will commence the domain name transition process and will solicit bids for a qualified ICANN-accredited registrar to manage the domain names currently managed by Mobile.co.

ICANN will follow the [De-Accredited Registrar Transition Procedure](#) ("Procedure"). Consistent with the Procedure, please designate a bulk transfer recipient by 29 June 2016 and inform ICANN's Registrar Liaison Team at RegTransition@icann.org.

ICANN reserves all its rights under the RAA. Please note the rights and obligations required to have effect after the expiration of the RAA, including but not limited to Sections 3.4 Retention of Registered Name Holder and Registration Data, 3.9 Accreditation Fees, 5.8 Resolution of Disputes Under this Agreement, and 5.9 Limitations on Monetary Remedies for Violations of this Agreement.

Mobile.co has past due accreditation fees. These fees are required to be paid to ICANN by Section 3.9 of the RAA. Please immediately submit payment to ICANN accounting.
