APP PRIVACY POLICY

App Users

Gathering of Personally-Identifying Information

Aggregated Statistics

We partner with certain mobile analytics, advertising, and technology partners. Such mobile partners may use a tracking pixel, agent or any other visitor identification technology that collects, uses, shares and stores data about end users and digital ad campaigns promoting our mobile or tablet applications.

Marmalade may use and share non-personally identifiable (e.g., anonymized or aggregated) information obtained from mobile or tablet applications with third parties such as service providers, analytics or advertising partners. An example of the use of such information would be a comparison between two anonymous groups of end users to compare the performance of different versions of the mobile application.

Protection of Certain Personally-Identifying Information
