NOTIFICATION

Consequent upon the recommendations of the Academic Council in its 21st meeting held on 09-07-2020 and the Syndicate in its 59th meeting held on 24-09-2020 approved the Admission Policy Government College University, Faisalabad Affiliated Colleges (Government and Private) under Semester and Annual system for the Academic Year 2020-21 as per details given below:

Government and Private under Semester System

- 1. Admission Policy for BS (4-years) Programmes/ MA/MSC(02-Years) & under Semester System
- All genders having domicile of Punjab are eligible for admission. ì.
- The candidates with at least 45% marks in FA/F.Sc./I.Com/ICS and A Level examination are eligible ii. to apply for all programmes except BS Engineering Technologies (Electrical/ Mechanical / Civil / Chemical), BSCS, BSIT and BS Software Engineering where at least 50% marks are required. However for DPT, Medical Health Professional Programmes (Medical Lab Technology (MLT), Radiography & Imaging Technology (RIT), Operation Theater Technology (OTT) etc.), where at least 60% marks are required as per the requirements of the respective Councils.
- Admission will be granted strictly on merit i.e. on the basis of the marks obtained in iii. FA/F.Sc./I.Com/ICS and A Level examinations in 2nd Annual 2019 and 1st Annual 2020. However, candidates of the earlier sessions will be considered by deducting 10 marks for each year for admission.
- The Class will be started with minimum 10 students. iv.
- Pre-requisites: V.

The following pre-requisites have been approved for the respective undergraduate programmes with the condition that the candidates must have studied these subjects at Secondary or Higher Secondary level for respective programmes:

- vi. Admission will be granted provisionally subject to verification of the certificates of the candidates from the relevant Secondary Board. Equivalence certificate is required from IBCC Islamabad/Lahore (where applicable).
- vii. The maximum age limit is 20 year on the closing date of applications.
- viii. Age relaxation may be granted in special cases upto 4 years by the Principal of the college subject to the availability of seats after accommodating all the fresh candidates.
 - 2. Admission Policy for Master programmes MA/MSc (02-Year).
 - i. Male/female candidates having domicile of only Punjab are eligible for admission.
 - ii. The candidates shall be eligible to apply for admission, who have:
 - a. At least 45% marks in terminal degree.
 - iii. The candidates who have passed BA/BSc or equivalent examination in 2nd Annual 2019 and 1st Annual 2020 will be considered for admission. However, candidates of earlier sessions will be considered by deducting 10 marks for each year for admission subject to availability of seats after accommodating fresh candidates.
 - iv. The maximum age limit is 26 years on the closing date of applications for Master programmes.
 Note: 05% seats for ADP in the respective programme

4. <u>University Dues</u>

The registration fee, sports fee, examinations fee and University share will be charged at the following rates for this year:-

Affiliated Colleges and Rs. 2830/- for students of Government affiliated colleges)

V) Degree Fee

The students who will complete their degrees successfully, they will pay Rs. 2500/- for receipt of their degrees.

5. Submission of Registration Return:-

After completion of admission, the online registration returns / Forms of all the admitted candidates will be sent to the office of the Additional Registrar (Registration), GCU, Faisalabad by the Principals of affiliated colleges alongwith the requisite registration & sports fee. In case of default in submission of registration return, the registration return will be submitted with the fine at the following rates

- ➤ With single fee Rs. 2000/- + sports fee Rs.800/- per year per student upto 16.11.2020
- ➤ Within fine of Rs. 500/-

upto 03.12.2020

With fine of Rs. 1000/-

upto 31.12.2020

After the expiry of 60 days (i.e. 31.12.2020) from the last date of admission, the Registration Return shall not be accepted in any case.

Note:- After expiry of the last date of admission, the Principal of the College shall ensure to submit the list of the admitted students within one week positively to the Additional Registrar (Registration), Government College University, Faisalabad, failing which no admission will be allowed thereafter in any case.

6. University reserves the right to change any clause of admission policy or refuse admission to any applicant without any reason.

Government and Private under Annual System

1. Admission Policy for ADA/ADS and ADC.

- i. The maximum age limit for the eligibility is 20 year on the closing date of the applications.
- ii. Age relaxation may be granted in special cases upto 4 years by the Principal of the college subject to availability of seats after accommodating fresh candidates.
- iii. Male/ female candidates having domicile of only Punjab are eligible for admission.
- iv. The candidates with at least 45% marks in FA/F.Sc./I.Com/ICS and A Level examination are eligible to apply for all programmes.
- v. Admission will be granted strictly on merit i.e. on the basis of the marks obtained in FA/F.Sc./I.Com/ICS and A Level examinations in 2nd Annual 2019 and 1st Annual 2020. However, candidates of the earlier sessions will be considered by deducting 10 marks for each year for admission.

- vi. Admission will be granted provisionally subject to verification of the certificates of the candidates from the relevant Secondary Board. Equivalence certificate is required from IBCC Islamabad/Lahore (where applicable).
- 2. Admission Policy for MA/M.Sc./M.Com (2-years) & M.Ed. (one year, Annual), etc.,
 - i. Male/female candidates having domicile of only Punjab are eligible for admission.
 - ii. The candidates shall be eligible to apply for admission, who have:
 - a. At least 45% marks in terminal degree.
- iii. The candidates who have passed BA/B.Sc./B.Com or equivalent examination in 2nd Annual 2019 and 1st Annual 2020 will be considered for admission. However, candidates of earlier sessions will be considered by deducting 10 marks for each year for admission subject to availability of seats after accommodating fresh candidates
- iv. The admission will be granted on open merit on the basis of following formula:
 - a. Total marks in BA/BSc/B.Com, in case of variation total marks will be converted out of 800 + marks obtained in the major subject (where applicable). However, Hafiz-e-Quran will be given 20 marks.

Note: The Principal will constitute the Committee for evaluation of the candidates of Hafiz-e-Quran for grant of 20 marks.

v. Maximum age limit is 26 years on the last date of receipt of applications. Furthermore, the Vice Chancellor has been authorized to amend any clause of the policy according to requirement.

5. Submission of Registration Return:-

In case of default in submission of registration return, the registration return will be submitted with the fine at the following rates

With fine of Rs. 500/- per student upto 03.12.2020 of the students admitted after 16-11-2020 to 03-12-2020

With fine of Rs. 1000/- per student of the students admitted after 03-12-2020 to 31-12-2020

Note:- After expiry of the last date of admission, the Principal of the College shall ensure to submit the list of the admitted students within one week positively to the Additional Registrar (Registration), Government College University, Faisalabad, failing which no admission will be allowed thereafter in any case.

After the expiry of 60 days (i.e. (31.12.2020) from the last date of admission, the Registration Return shall not be accepted from any of the affiliated colleges in any case. However, in special cases considering the genuineness of delay, registration return may be accepted with special fine on the following rates (in addition to prescribed registration and sports fee, only if the name of student is mentioned in the list of admitted students already forwarded to the Additional Registrar (Registration):-

a) Within 30 days of expiry of schedule Rs.2000/- per student plus Rs.5000/- per discipline

b) Within 60 days of expiry of schedule Rs.3000/- per student plus Rs.5000/- per discipline
