## 1 Using

To date, **libiberty** is generally not installed on its own. It has evolved over years but does not have its own version number nor release schedule.

Possibly the easiest way to use libiberty in your projects is to drop the libiberty code into your project's sources, and to build the library along with your own sources; the library would then be linked in at the end. This prevents any possible version mismatches with other copies of libiberty elsewhere on the system.

Passing '--enable-install-libiberty' to the configure script when building libiberty causes the header files and archive library to be installed when *make install* is run. This option also takes an (optional) argument to specify the installation location, in the same manner as '--prefix'.

For your own projects, an approach which offers stability and flexibility is to include **libiberty** with your code, but allow the end user to optionally choose to use a previouslyinstalled version instead. In this way the user may choose (for example) to install **libiberty** as part of GCC, and use that version for all software built with that compiler. (This approach has proven useful with software using the GNU **readline** library.)

Making use of libiberty code usually requires that you include one or more header files from the libiberty distribution. (They will be named as necessary in the function descriptions.) At link time, you will need to add '-liberty' to your link command invocation.

## 2 Overview

Functions contained in libiberty can be divided into three general categories.

## 2.1 Supplemental Functions

Certain operating systems do not provide functions which have since become standardized, or at least common. For example, the Single Unix Specification Version 2 requires that the **basename** function be provided, but an OS which predates that specification might not have this function. This should not prevent well-written code from running on such a system.

Similarly, some functions exist only among a particular "flavor" or "family" of operating systems. As an example, the **bzero** function is often not present on systems outside the BSD-derived family of systems.

Many such functions are provided in libiberty. They are quickly listed here with little description, as systems which lack them become less and less common. Each function *foo* is implemented in '*foo*.c' but not declared in any libiberty header file; more comments and caveats for each function's implementation are often available in the source file. Generally, the function can simply be declared as extern.

## 2.2 Replacement Functions

Some functions have extremely limited implementations on different platforms. Other functions are tedious to use correctly; for example, proper use of malloc calls for the return value to be checked and appropriate action taken if memory has been exhausted. A group of "replacement functions" is available in libiberty to address these issues for some of the most commonly used subroutines.

All of these functions are declared in the 'libiberty.h' header file. Many of the implementations will use preprocessor macros set by GNU Autoconf, if you decide to make use of that program. Some of these functions may call one another.

## 2.2.1 Memory Allocation

The functions beginning with the letter 'x' are wrappers around standard functions; the functions provided by the system environment are called and their results checked before the results are passed back to client code. If the standard functions fail, these wrappers will terminate the program. Thus, these versions can be used with impunity.

## 2.2.2 Exit Handlers

The existence and implementation of the **atexit** routine varies amongst the flavors of Unix. **libiberty** provides an unvarying dependable implementation via **xatexit** and **xexit**.

## 2.2.3 Error Reporting

These are a set of routines to facilitate programming with the system **errno** interface. The **libiberty** source file '**strerror.c**' contains a good deal of documentation for these functions.

## 2.3 Extensions

**libiberty** includes additional functionality above and beyond standard functions, which has proven generically useful in GNU programs, such as obstacks and regex. These functions are often copied from other projects as they gain popularity, and are included here to provide a central location from which to use, maintain, and distribute them.

## 2.3.1 Obstacks

An obstack is a pool of memory containing a stack of objects. You can create any number of separate obstacks, and then allocate objects in specified obstacks. Within each obstack, the last object allocated must always be the first one freed, but distinct obstacks are independent of each other.

Aside from this one constraint of order of freeing, obstacks are totally general: an obstack can contain any number of objects of any size. They are implemented with macros, so allocation is usually very fast as long as the objects are usually small. And the only space overhead per object is the padding needed to start each object on a suitable boundary.

## 2.3.1.1 Creating Obstacks

The utilities for manipulating obstacks are declared in the header file 'obstack.h'.

## struct obstack

[Data Type]

An obstack is represented by a data structure of type **struct obstack**. This structure has a small fixed size; it records the status of the obstack and how to find the space in which objects are allocated. It does not contain any of the objects themselves. You should not try to access the contents of the structure directly; use only the macros described in this chapter.

You can declare variables of type struct obstack and use them as obstacks, or you can allocate obstacks dynamically like any other kind of object. Dynamic allocation of obstacks allows your program to have a variable number of different stacks. (You can even allocate an obstack structure in another obstack, but this is rarely useful.)

All the macros that work with obstacks require you to specify which obstack to use. You do this with a pointer of type struct obstack \*. In the following, we often say "an obstack" when strictly speaking the object at hand is such a pointer.

The objects in the obstack are packed into large blocks called *chunks*. The struct obstack structure points to a chain of the chunks currently in use.

The obstack library obtains a new chunk whenever you allocate an object that won't fit in the previous chunk. Since the obstack library manages chunks automatically, you don't need to pay much attention to them, but you do need to supply a function which the obstack library should use to get a chunk. Usually you supply a function which uses malloc directly or indirectly. You must also supply a function to free a chunk. These matters are described in the following section.

## 2.3.1.2 Preparing for Using Obstacks

Each source file in which you plan to use obstacks must include the header file 'obstack.h', like this:

#### #include <obstack.h>

Also, if the source file uses the macro obstack\_init, it must declare or define two macros that will be called by the obstack library. One, obstack\_chunk\_alloc, is used to allocate the chunks of memory into which objects are packed. The other, obstack\_chunk\_free, is used to return chunks when the objects in them are freed. These macros should appear before any use of obstacks in the source file.

Usually these are defined to use malloc via the intermediary xmalloc (see Section "Unconstrained Allocation" in *The GNU C Library Reference Manual*). This is done with the following pair of macro definitions:

#define obstack\_chunk\_alloc xmalloc
#define obstack\_chunk\_free free

Though the memory you get using obstacks really comes from malloc, using obstacks is faster because malloc is called less often, for larger blocks of memory. See Section 2.3.1.10 [Obstack Chunks], page 11, for full details.

At run time, before the program can use a struct obstack object as an obstack, it must initialize the obstack by calling obstack\_init or one of its variants, obstack\_begin, obstack\_specify\_allocation, or obstack\_specify\_allocation\_with\_arg.

```
int obstack_init (struct obstack *obstack-ptr) [Function]
Initialize obstack obstack-ptr for allocation of objects. This macro calls the obstack's
obstack_chunk_alloc function. If allocation of memory fails, the function pointed
to by obstack_alloc_failed_handler is called. The obstack_init macro always
returns 1 (Compatibility notice: Former versions of obstack returned 0 if allocation
failed).
```

Here are two examples of how to allocate the space for an obstack and initialize it. First, an obstack that is a static variable:

```
static struct obstack myobstack;
...
obstack_init (&myobstack);
```

Second, an obstack that is itself dynamically allocated:

struct obstack \*myobstack\_ptr
 = (struct obstack \*) xmalloc (sizeof (struct obstack));
obstack\_init (myobstack\_ptr);

- int obstack\_begin (struct obstack \*obstack-ptr, size\_t chunk\_size) [Function] Like obstack\_init, but specify chunks to be at least chunk\_size bytes in size.

Like obstack\_init, specifying chunk size, chunk alignment, and memory allocation functions. A *chunk\_size* or *alignment* of zero results in the default size or alignment respectively being used.

Like obstack\_specify\_allocation, but specifying memory allocation functions that take an extra first argument, *arg*.

#### obstack\_alloc\_failed\_handler

[Variable]

The value of this variable is a pointer to a function that obstack uses when obstack\_ chunk\_alloc fails to allocate memory. The default action is to print a message and abort. You should supply a function that either calls exit (see Section "Program Termination" in The GNU C Library Reference Manual) or longjmp (see Section "Non-Local Exits" in The GNU C Library Reference Manual) and doesn't return.

void my\_obstack\_alloc\_failed (void)

obstack\_alloc\_failed\_handler = &my\_obstack\_alloc\_failed;

## 2.3.1.3 Allocation in an Obstack

The most direct way to allocate an object in an obstack is with obstack\_alloc, which is invoked almost like malloc.

void \* obstack\_alloc (struct obstack \*obstack-ptr, size\_t size) [Function]
This allocates an uninitialized block of size bytes in an obstack and returns its address.
Here obstack-ptr specifies which obstack to allocate the block in; it is the address
of the struct obstack object which represents the obstack. Each obstack macro
requires you to specify an obstack-ptr as the first argument.

This macro calls the obstack's obstack\_chunk\_alloc function if it needs to allocate a new chunk of memory; it calls obstack\_alloc\_failed\_handler if allocation of memory by obstack\_chunk\_alloc failed.

For example, here is a function that allocates a copy of a string *str* in a specific obstack, which is in the variable **string\_obstack**:

```
struct obstack string_obstack;
char *
copystring (char *string)
{
    size_t len = strlen (string) + 1;
    char *s = (char *) obstack_alloc (&string_obstack, len);
    memcpy (s, string, len);
    return s;
}
```

To allocate a block with specified contents, use the macro obstack\_copy.

This allocates a block and initializes it by copying *size* bytes of data starting at *address*. It calls obstack\_alloc\_failed\_handler if allocation of memory by obstack\_chunk\_alloc failed.

Like obstack\_copy, but appends an extra byte containing a null character. This extra byte is not counted in the argument *size*.

The obstack\_copy0 macro is convenient for copying a sequence of characters into an obstack as a null-terminated string. Here is an example of its use:

```
char *
obstack_savestring (char *addr, size_t size)
{
    return obstack_copy0 (&myobstack, addr, size);
}
```

Contrast this with the previous example of savestring using malloc (see Section "Basic Allocation" in The GNU C Library Reference Manual).

## 2.3.1.4 Freeing Objects in an Obstack

To free an object allocated in an obstack, use the macro **obstack\_free**. Since the obstack is a stack of objects, freeing one object automatically frees all other objects allocated more recently in the same obstack.

```
void obstack_free (struct obstack *obstack-ptr, void *object) [Function]
If object is a null pointer, everything allocated in the obstack is freed. Otherwise,
object must be the address of an object allocated in the obstack. Then object is freed,
along with everything allocated in obstack since object.
```

Note that if *object* is a null pointer, the result is an uninitialized obstack. To free all memory in an obstack but leave it valid for further allocation, call **obstack\_free** with the address of the first object allocated on the obstack:

obstack\_free (obstack\_ptr, first\_object\_allocated\_ptr);

Recall that the objects in an obstack are grouped into chunks. When all the objects in a chunk become free, the obstack library automatically frees the chunk (see Section 2.3.1.2 [Preparing for Obstacks], page 3). Then other obstacks, or non-obstack allocation, can reuse the space of the chunk.

## 2.3.1.5 Obstack Functions and Macros

The interfaces for using obstacks are shown here as functions to specify the return type and argument types, but they are really defined as macros. This means that the arguments don't actually have types, but they generally behave as if they have the types shown. You can call these macros like functions, but you cannot use them in any other way (for example, you cannot take their address).

Calling the macros requires a special precaution: namely, the first operand (the obstack pointer) may not contain any side effects, because it may be computed more than once. For example, if you write this:

```
obstack_alloc (get_obstack (), 4);
```

you will find that get\_obstack may be called several times. If you use \*obstack\_list\_ ptr++ as the obstack pointer argument, you will get very strange results since the incrementation may occur several times. If you use the GNU C compiler, this precaution is not necessary, because various language extensions in GNU C permit defining the macros so as to compute each argument only once.

Note that arguments other than the first will only be evaluated once, even when not using GNU C.

obstack.h does declare a number of functions, \_obstack\_begin, \_obstack\_begin\_1, \_obstack\_newchunk, \_obstack\_free, and \_obstack\_memory\_used. You should not call these directly.

## 2.3.1.6 Growing Objects

Because memory in obstack chunks is used sequentially, it is possible to build up an object step by step, adding one or more bytes at a time to the end of the object. With this technique, you do not need to know how much data you will put in the object until you come to the end of it. We call this the technique of growing objects. The special macros for adding data to the growing object are described in this section.

You don't need to do anything special when you start to grow an object. Using one of the macros to add data to the object automatically starts it. However, it is necessary to say explicitly when the object is finished. This is done with obstack\_finish.

The actual address of the object thus built up is not known until the object is finished. Until then, it always remains possible that you will add so much data that the object must be copied into a new chunk.

While the obstack is in use for a growing object, you cannot use it for ordinary allocation of another object. If you try to do so, the space already added to the growing object will become part of the other object.

- void obstack\_blank (struct obstack \*obstack-ptr, size\_t size) [Function]
  The most basic macro for adding to a growing object is obstack\_blank, which adds
  space without initializing it.

To add a block of initialized space, use obstack\_grow, which is the growing-object analogue of obstack\_copy. It adds size bytes of data to the growing object, copying the contents from *data*.

This is the growing-object analogue of obstack\_copy0. It adds *size* bytes copied from *data*, followed by an additional null character.

- void obstack\_1grow (struct obstack \*obstack-ptr, char c) [Function]
  To add one character at a time, use obstack\_1grow. It adds a single byte containing
  c to the growing object.
- void obstack\_ptr\_grow (struct obstack \*obstack-ptr, void \*data) [Function]
  Adding the value of a pointer one can use obstack\_ptr\_grow. It adds sizeof (void
  \*) bytes containing the value of data.

- void obstack\_int\_grow (struct obstack \*obstack-ptr, int data) [Function]
  A single value of type int can be added by using obstack\_int\_grow. It adds sizeof
  (int) bytes to the growing object and initializes them with the value of data.
- void \* obstack\_finish (struct obstack \*obstack-ptr) [Function]
  When you are finished growing the object, use obstack\_finish to close it off and
  return its final address.

Once you have finished the object, the obstack is available for ordinary allocation or for growing another object.

When you build an object by growing it, you will probably need to know afterward how long it became. You need not keep track of this as you grow the object, because you can find out the length from the obstack with obstack\_object\_size, before finishing the object.

size\_t obstack\_object\_size (struct obstack \*obstack-ptr) [Function]
This macro returns the current size of the growing object, in bytes. Remember to
call obstack\_object\_size before finishing the object. After it is finished, obstack\_
object\_size will return zero.

If you have started growing an object and wish to cancel it, you should finish it and then free it, like this:

```
obstack_free (obstack_ptr, obstack_finish (obstack_ptr));
```

This has no effect if no object was growing.

## 2.3.1.7 Extra Fast Growing Objects

The usual macros for growing objects incur overhead for checking whether there is room for the new growth in the current chunk. If you are frequently constructing objects in small steps of growth, this overhead can be significant.

You can reduce the overhead by using special "fast growth" macros that grow the object without checking. In order to have a robust program, you must do the checking yourself. If you do this checking in the simplest way each time you are about to add data to the object, you have not saved anything, because that is what the ordinary growth macros do. But if you can arrange to check less often, or check more efficiently, then you make the program faster.

obstack\_room returns the amount of room available in the current chunk.

size\_t obstack\_room (struct obstack \*obstack-ptr) [Function]
This returns the number of bytes that can be added safely to the current growing
object (or to an object about to be started) in obstack obstack using the fast growth
macros.

While you know there is room, you can use these fast growth macros for adding data to a growing object:

void obstack\_1grow\_fast (struct obstack \*obstack-ptr, char c) [Function]
obstack\_1grow\_fast adds one byte containing the character c to the growing object
in obstack obstack-ptr.

obstack\_ptr\_grow\_fast adds sizeof (void \*) bytes containing the value of data to the growing object in obstack obstack-ptr.

obstack\_int\_grow\_fast adds sizeof (int) bytes containing the value of data to the growing object in obstack obstack-ptr.

void obstack\_blank\_fast (struct obstack \*obstack-ptr, size\_t size) [Function]
obstack\_blank\_fast adds size bytes to the growing object in obstack obstack-ptr
without initializing them.

When you check for space using obstack\_room and there is not enough room for what you want to add, the fast growth macros are not safe. In this case, simply use the corresponding ordinary growth macro instead. Very soon this will copy the object to a new chunk; then there will be lots of room available again.

So, each time you use an ordinary growth macro, check afterward for sufficient space using obstack\_room. Once the object is copied to a new chunk, there will be plenty of space again, so the program will start using the fast growth macros again.

Here is an example:

```
void
add_string (struct obstack *obstack, const char *ptr, size_t len)
ł
 while (len > 0)
    {
      size_t room = obstack_room (obstack);
      if (room == 0)
        {
          /* Not enough room. Add one character slowly,
             which may copy to a new chunk and make room. */
          obstack_1grow (obstack, *ptr++);
          len--;
        }
      else
        {
          if (room > len)
            room = len;
          /* Add fast as much as we have room for. */
          len -= room;
          while (room-- > 0)
            obstack_1grow_fast (obstack, *ptr++);
        }
   }
}
```

You can use obstack\_blank\_fast with a "negative" size argument to make the current object smaller. Just don't try to shrink it beyond zero length—there's no telling what will happen if you do that. Earlier versions of obstacks allowed you to use obstack\_blank to shrink objects. This will no longer work.

## 2.3.1.8 Status of an Obstack

Here are macros that provide information on the current status of allocation in an obstack. You can use them to learn about an object while still growing it.

void \* obstack\_base (struct obstack \*obstack-ptr) [Function]
This macro returns the tentative address of the beginning of the currently growing
object in obstack-ptr. If you finish the object immediately, it will have that address.
If you make it larger first, it may outgrow the current chunk—then its address will
change!

If no object is growing, this value says where the next object you allocate will start (once again assuming it fits in the current chunk).

- void \* obstack\_next\_free (struct obstack \*obstack-ptr) [Function]
  This macro returns the address of the first free byte in the current chunk of obstack
  obstack-ptr. This is the end of the currently growing object. If no object is growing,
  obstack\_next\_free returns the same value as obstack\_base.
- size\_t obstack\_object\_size (struct obstack \*obstack-ptr) [Function]
  This macro returns the size in bytes of the currently growing object. This is equivalent
  to

((size\_t) (obstack\_next\_free (obstack-ptr) - obstack\_base (obstack-ptr)))

## 2.3.1.9 Alignment of Data in Obstacks

Each obstack has an *alignment boundary*; each object allocated in the obstack automatically starts on an address that is a multiple of the specified boundary. By default, this boundary is aligned so that the object can hold any type of data.

To access an obstack's alignment boundary, use the macro obstack\_alignment\_mask.

size\_t obstack\_alignment\_mask (struct obstack \*obstack-ptr) [Macro] The value is a bit mask; a bit that is 1 indicates that the corresponding bit in the address of an object should be 0. The mask value should be one less than a power of 2; the effect is that all object addresses are multiples of that power of 2. The default value of the mask is a value that allows aligned objects to hold any type of data: for example, if its value is 3, any type of data can be stored at locations whose addresses are multiples of 4. A mask value of 0 means an object can start on any multiple of 1 (that is, no alignment is required).

The expansion of the macro obstack\_alignment\_mask is an lvalue, so you can alter the mask by assignment. For example, this statement:

```
obstack_alignment_mask (obstack_ptr) = 0;
```

has the effect of turning off alignment processing in the specified obstack.

Note that a change in alignment mask does not take effect until *after* the next time an object is allocated or finished in the obstack. If you are not growing an object, you can make the new alignment mask take effect immediately by calling **obstack\_finish**. This will finish a zero-length object and then do proper alignment for the next object.

## 2.3.1.10 Obstack Chunks

Obstacks work by allocating space for themselves in large chunks, and then parceling out space in the chunks to satisfy your requests. Chunks are normally 4096 bytes long unless you specify a different chunk size. The chunk size includes 8 bytes of overhead that are not actually used for storing objects. Regardless of the specified size, longer chunks will be allocated when necessary for long objects.

The obstack library allocates chunks by calling the function obstack\_chunk\_alloc, which you must define. When a chunk is no longer needed because you have freed all the objects in it, the obstack library frees the chunk by calling obstack\_chunk\_free, which you must also define.

These two must be defined (as macros) or declared (as functions) in each source file that uses obstack\_init (see Section 2.3.1.1 [Creating Obstacks], page 3). Most often they are defined as macros like this:

#define obstack\_chunk\_alloc malloc
#define obstack\_chunk\_free free

Note that these are simple macros (no arguments). Macro definitions with arguments will not work! It is necessary that obstack\_chunk\_alloc or obstack\_chunk\_free, alone, expand into a function name if it is not itself a function name.

If you allocate chunks with malloc, the chunk size should be a power of 2. The default chunk size, 4096, was chosen because it is long enough to satisfy many typical requests on the obstack yet short enough not to waste too much memory in the portion of the last chunk not yet used.

```
size_t obstack_chunk_size (struct obstack *obstack-ptr) [Macro]
This returns the chunk size of the given obstack.
```

Since this macro expands to an lvalue, you can specify a new chunk size by assigning it a new value. Doing so does not affect the chunks already allocated, but will change the size of chunks allocated for that particular obstack in the future. It is unlikely to be useful to make the chunk size smaller, but making it larger might improve efficiency if you are allocating many objects whose size is comparable to the chunk size. Here is how to do so cleanly:

if (obstack\_chunk\_size (obstack\_ptr) < new-chunk-size)
 obstack\_chunk\_size (obstack\_ptr) = new-chunk-size;</pre>

## 2.3.1.11 Summary of Obstack Macros

Here is a summary of all the macros associated with obstacks. Each takes the address of an obstack (struct obstack \*) as its first argument.

int obstack\_init (struct obstack \*obstack-ptr) Initialize use of an obstack. See Section 2.3.1.1 [Creating Obstacks], page 3.

```
int obstack_begin (struct obstack *obstack-ptr, size_t chunk_size)
Initialize use of an obstack, with an initial chunk of chunk_size bytes.
```

int obstack\_specify\_allocation (struct obstack \*obstack-ptr, size\_t chunk\_size, size\_t alignment, void \*(\*chunkfun) (size\_t), void (\*freefun) (void \*))

Initialize use of an obstack, specifying intial chunk size, chunk alignment, and memory allocation functions.

int obstack\_specify\_allocation\_with\_arg (struct obstack \*obstack-ptr, size\_t chunk\_size, size\_t alignment, void \*(\*chunkfun) (void \*, size\_t), void

```
(*freefun) (void *, void *), void *arg)
```

Like obstack\_specify\_allocation, but specifying memory allocation functions that take an extra first argument, *arg*.

- void \*obstack\_alloc (struct obstack \*obstack-ptr, size\_t size)
  Allocate an object of size uninitialized bytes. See Section 2.3.1.3 [Allocation in
  an Obstack], page 5.
- void \*obstack\_copy (struct obstack \*obstack-ptr, void \*address, size\_t size)
  Allocate an object of size bytes, with contents copied from address. See
  Section 2.3.1.3 [Allocation in an Obstack], page 5.
- void \*obstack\_copy0 (struct obstack \*obstack-ptr, void \*address, size\_t size)
  Allocate an object of size+1 bytes, with size of them copied from address,
  followed by a null character at the end. See Section 2.3.1.3 [Allocation in an
  Obstack], page 5.
- void obstack\_free (struct obstack \*obstack-ptr, void \*object)
  Free object (and everything allocated in the specified obstack more recently
  than object). See Section 2.3.1.4 [Freeing Obstack Objects], page 6.

## 3 Function, Variable, and Macro Listing.

void\* alloca (size\_t size) [Replacement] This function allocates memory which will be automatically reclaimed after the procedure exits. The libiberty implementation does not free the memory immediately but will do so eventually during subsequent calls to this function. Memory is allocated using xmalloc under normal circumstances.

The header file 'alloca-conf.h' can be used in conjunction with the GNU Autoconf test AC\_FUNC\_ALLOCA to test for and properly make available this function. The AC\_ FUNC\_ALLOCA test requires that client code use a block of preprocessor code to be safe (see the Autoconf manual for more); this header incorporates that logic and more, including the possibility of a GCC built-in function.

- int asprintf (char \*\*resptr, const char \*format, ...) [Extension] Like sprintf, but instead of passing a pointer to a buffer, you pass a pointer to a pointer. This function will compute the size of the buffer needed, allocate memory with malloc, and store a pointer to the allocated memory in **\*resptr**. The value returned is the same as **sprintf** would return. If memory could not be allocated, minus one is returned and NULL is stored in **\*resptr**.
- int atexit (void (\*f)()) [Supplemental] Causes function f to be called at exit. Returns 0.
- char\* basename (const char \*name) [Supplemental] Returns a pointer to the last component of pathname name. Behavior is undefined if the pathname ends in a directory separator.
- int bcmp (char \*x, char \*y, int count) [Supplemental] Compares the first *count* bytes of two areas of memory. Returns zero if they are the same, nonzero otherwise. Returns zero if *count* is zero. A nonzero result only indicates a difference, it does not indicate any sorting order (say, by having a positive result mean x sorts before y).
- void bcopy (char \*in, char \*out, int length) [Supplemental] Copies length bytes from memory region in to region out. The use of bcopy is deprecated in new programs.
- void\* bsearch (const void \*key, const void \*base, size\_t nmemb, [Supplemental] size\_t size, int (\*compar)(const void \*, const void \*))

Performs a search over an array of *nmemb* elements pointed to by base for a member that matches the object pointed to by key. The size of each member is specified by size. The array contents should be sorted in ascending order according to the compar comparison function. This routine should take two arguments pointing to the key and to an array member, in that order, and should return an integer less than, equal to, or greater than zero if the key object is respectively less than, matching, or greater than the array member.

void\* bsearch\_r (const void \*key, const void \*base, size\_t nmemb, [Supplemental] size\_t size, int (\*compar)(const void \*, const void \*, void \*), void \*arg)

Performs a search over an array of *nmemb* elements pointed to by *base* for a member that matches the object pointed to by *key*. The size of each member is specified by *size*. The array contents should be sorted in ascending order according to the *compar* comparison function. This routine should take three arguments: the first two point to the *key* and to an array member, and the last is passed down unchanged from **bsearch\_r**'s last argument. It should return an integer less than, equal to, or greater than zero if the *key* object is respectively less than, matching, or greater than the array member.

#### char\*\* buildargv (char \*sp)

#### [Extension]

Given a pointer to a string, parse the string extracting fields separated by whitespace and optionally enclosed within either single or double quotes (which are stripped off), and build a vector of pointers to copies of the string for each field. The input string remains unchanged. The last element of the vector is followed by a NULL element.

All of the memory for the pointer array and copies of the string is obtained from xmalloc. All of the memory can be returned to the system with the single function call freeargy, which takes the returned result of buildargy, as it's argument.

Returns a pointer to the argument vector if successful. Returns NULL if sp is NULL or if there is insufficient memory to complete building the argument vector.

If the input is a null string (as opposed to a NULL pointer), then buildarg returns an argument vector that has one arg, a null string.

  Return a prefix for temporary file names or NULL if unable to find one. The current
  directory is chosen if all else fails so the program is exited if a temporary directory
  can't be found (mktemp fails). The buffer for the result is obtained with xmalloc.

This function is provided for backwards compatibility only. Its use is not recommended.

const char\* choose\_tmpdir () [Replacement] Returns a pointer to a directory path suitable for creating temporary files in.

- long clock (void) [Supplemental] Returns an approximation of the CPU time used by the process as a clock\_t; divide this number by 'CLOCKS\_PER\_SEC' to get the number of seconds used.
- char\* concat (const char \*s1, const char \*s2, ..., NULL) [Extension] Concatenate zero or more of strings and return the result in freshly xmalloced memory. The argument list is terminated by the first NULL pointer encountered. Pointers to empty strings are ignored.
- int countargv (char \* const \* argv) [Extension] Return the number of elements in argy. Returns zero if argy is NULL.
- unsigned int crc32 (const unsigned char \*buf, int len, unsigned int [Extension] init)

Compute the 32-bit CRC of *buf* which has length *len*. The starting value is *init*; this may be used to compute the CRC of data split across multiple buffers by passing the return value of each call as the *init* parameter of the next.

This is used by the gdb remote protocol for the 'qCRC' command. In order to get the same results as gdb for a block of data, you must pass the first CRC parameter as Oxffffffff.

This CRC can be specified as:

Width: 32 Poly: 0x04c11db7 Init: parameter, typically 0xfffffff RefIn: false RefOut : false XorOut : 0

This differs from the "standard" CRC-32 algorithm in that the values are not reflected, and there is no final XOR value. These differences make it easy to compose the values of multiple blocks.

Duplicate an argument vector. Simply scans through vector, duplicating each argument until the terminating NULL is found. Returns a pointer to the argument vector if successful. Returns NULL if there is insufficient memory to complete building the argument vector.

#### int errno\_max (void)

Returns the maximum errno value for which a corresponding symbolic name or message is available. Note that in the case where we use the **sys\_errlist** supplied by the system, it is possible for there to be more symbolic names than messages, or vice versa. In fact, the manual page for perror(3C) explicitly warns that one should check the size of the table (sys\_nerr) before indexing it, since new error codes may be added to the system before they are added to the table. Thus sys\_nerr might be smaller than value implied by the largest errno value defined in <errno.h>.

We return the maximum value that can be used to obtain a meaningful symbolic name or message.

#### void expandargv (*int* \*argcp, *char* \*\*\*argvp) [Extension] The argcp and argvp arguments are pointers to the usual argc and argv arguments to main. This function looks for arguments that begin with the character 'Q'. Any such arguments are interpreted as "response files". The contents of the response

file are interpreted as additional command line options. In particular, the file is separated into whitespace-separated strings; each such string is taken as a commandline option. The new options are inserted in place of the option naming the response file, and **\*argcp** and **\*argvp** will be updated. If the value of **\*argvp** is modified by this function, then the new value has been dynamically allocated and can be deallocated by the caller with **freeargv**. However, most callers will simply call **expandargv** near the beginning of **main** and allow the operating system to free the memory when the program exits.

int fdmatch (int fd1, int fd2) [Extension] Check to see if two open file descriptors refer to the same file. This is useful, for example, when we have an open file descriptor for an unnamed file, and the name of a file that we believe to correspond to that fd. This can happen when we are exec'd with an already open file (stdout for example) or from the SVR4 '/proc' calls that return open file descriptors for mapped address spaces. All we have to do is open the file by name and check the two file descriptors for a match, which is done by comparing major and minor device numbers and inode numbers.

- FILE \* fdopen\_unlocked (int fildes, const char \* mode)[Extension]Opens and returns a FILE pointer via fdopen. If the operating system supports it,<br/>ensure that the stream is setup to avoid any multi-threaded locking. Otherwise return<br/>the FILE pointer unchanged.
- int ffs (int valu)

Find the first (least significant) bit set in valu. Bits are numbered from right to left, starting with bit 1 (corresponding to the value 1). If valu is zero, zero is returned.

int filename\_cmp (const char \*s1, const char \*s2) [Extension] Return zero if the two file names s1 and s2 are equivalent. If not equivalent, the returned value is similar to what strcmp would return. In other words, it returns a negative value if s1 is less than s2, or a positive value if s2 is greater than s2.

This function does not normalize file names. As a result, this function will treat filenames that are spelled differently as different even in the case when the two filenames point to the same underlying file. However, it does handle the fact that on DOS-like file systems, forward and backward slashes are equal.

- int filename\_eq (const void \*s1, const void \*s2) [Extension] Return non-zero if file names s1 and s2 are equivalent. This function is for use with hashtab.c hash tables.
- hashval\_t filename\_hash (const void \*s) [Extension] Return the hash value for file name s that will be compared using filename\_cmp. This function is for use with hashtab.c hash tables.
- int filename\_ncmp (const char \*s1, const char \*s2, size\_t n) [Extension]

flags controls various aspects of the matching process, and is a boolean OR of zero or more of the following values (defined in <fnmatch.h>):

Do not interpret backslashes as quoting the following special character.

#### FNM\_LEADING\_DIR

Means that *string* also matches *pattern* if some initial part of *string* matches, and is followed by / and zero or more characters. For example, 'foo\*' would match either 'foobar' or 'foobar/grill'.

#### FNM\_CASEFOLD

Ignores case when performing the comparison.

FILE \* fopen\_unlocked (const char \*path, const char \* mode) [Extension] Opens and returns a FILE pointer via fopen. If the operating system supports it, ensure that the stream is setup to avoid any multi-threaded locking. Otherwise return the FILE pointer unchanged.

# void freeargv (char \*\*vector) [Extension] Free an argument vector that was built using buildargv. Simply scans through vector, freeing the memory for each argument until the terminating NULL is found, and then frees vector itself.

FILE \* stream)

Opens and returns a FILE pointer via freopen. If the operating system supports it, ensure that the stream is setup to avoid any multi-threaded locking. Otherwise return the FILE pointer unchanged.

long get\_run\_time (void) [Replacement] Returns the time used so far, in microseconds. If possible, this is the time used by this process, else it is the elapsed time since the process started.

char\* getcwd (char \*pathname, int len) [Supplemental] Copy the absolute pathname for the current working directory into pathname, which is assumed to point to a buffer of at least len bytes, and return a pointer to the buffer. If the current directory's path doesn't fit in len characters, the result is NULL and errno is set. If pathname is a null pointer, getcwd will obtain len bytes of space using malloc.

int getpagesize (void)

Returns the number of bytes in a page of memory. This is the granularity of many of the system memory management routines. No guarantee is made as to whether or not it is the same as the basic memory management hardware page size.

char\* getpwd (void)

Returns the current working directory. This implementation caches the result on the assumption that the process will not call chdir between calls to getpwd.

int gettimeofday (struct timeval \*tp, void \*tz) [Supplemental] Writes the current time to tp. This implementation requires that tz be NULL. Returns 0 on success, -1 on failure.

#### void hex\_init (void)

Initializes the array mapping the current character set to corresponding hex values. This function must be called before any call to hex\_p or hex\_value. If you fail to call it, a default ASCII-based table will normally be used on ASCII systems.

int hex\_p (int c)

Evaluates to non-zero if the given character is a valid hex character, or zero if it is not. Note that the value you pass will be cast to **unsigned char** within the macro.

#### unsigned int hex\_value (int c)

Returns the numeric equivalent of the given character when interpreted as a hexadecimal digit. The result is undefined if you pass an invalid hex digit. Note that the value you pass will be cast to **unsigned char** within the macro.

The hex\_value macro returns unsigned int, rather than signed int, to make it easier to use in parsing addresses from hex dump files: a signed int would be sign-extended when converted to a wider unsigned type — like bfd\_vma, on some systems.

The name of the input file is chosen according to the same rules pex\_run uses to choose output file names, based on *in\_name*, *obj* and the PEX\_SUFFIX bit in flags.

Don't call fclose on the returned stream; the first call to pex\_run closes it automatically.

If flags includes PEX\_BINARY\_OUTPUT, open the stream in binary mode; otherwise, open it in the default mode. Including PEX\_BINARY\_OUTPUT in flags has no effect on Unix.

FILE \* pex\_input\_pipe (struct pex\_obj \*obj, int binary) [Extension] Return a stream fp for a pipe connected to the standard input of the first program in the pipeline; fp is opened for writing. You must have passed PEX\_USE\_PIPES to the pex\_init call that returned obj.

You must close fp using fclose yourself when you have finished writing data to the pipeline.

The file descriptor underlying *fp* is marked not to be inherited by child processes.

On systems that do not support pipes, this function returns NULL, and sets errno to EINVAL. If you would like to write code that is portable to all systems the pex functions support, consider using pex\_input\_file instead.

There are two opportunities for deadlock using pex\_input\_pipe:

- Most systems' pipes can buffer only a fixed amount of data; a process that writes to a full pipe blocks. Thus, if you write to 'fp' before starting the first process, you run the risk of blocking when there is no child process yet to read the data and allow you to continue. pex\_input\_pipe makes no promises about the size of the pipe's buffer, so if you need to write any data at all before starting the first process in the pipeline, consider using pex\_input\_file instead.
- Using pex\_input\_pipe and pex\_read\_output together may also cause deadlock. If the output pipe fills up, so that each program in the pipeline is waiting for the next to read more data, and you fill the input pipe by writing more data to *fp*, then there is no way to make progress: the only process that could read data from the output pipe is you, but you are blocked on the input pipe.

An interface to permit the easy execution of a single program. The return value and most of the parameters are as for a call to pex\_run. *flags* is restricted to a combination of PEX\_SEARCH, PEX\_STDERR\_TO\_STDOUT, and PEX\_BINARY\_OUTPUT. *outname* is interpreted as if PEX\_LAST were set. On a successful return, \*status will be set to the exit status of the program.

- FILE \* pex\_read\_err (struct pex\_obj \*obj, int binary) [Extension] Returns a FILE pointer which may be used to read the standard error of the last program in the pipeline. When this is used, PEX\_LAST should not be used in a call to pex\_run. After this is called, pex\_run may no longer be called with the same obj. binary should be non-zero if the file should be opened in binary mode. Don't call fclose on the returned file; it will be closed by pex\_free.
- FILE \* pex\_read\_output (struct pex\_obj \*obj, int binary) [Extension]
  Returns a FILE pointer which may be used to read the standard output of the last
  program in the pipeline. When this is used, PEX\_LAST should not be used in a call
  to pex\_run. After this is called, pex\_run may no longer be called with the same obj.
  binary should be non-zero if the file should be opened in binary mode. Don't call
  fclose on the returned file; it will be closed by pex\_free.

Execute one program in a pipeline. On success this returns NULL. On failure it returns an error message, a statically allocated string.

obj is returned by a previous call to pex\_init.

flags is a bitwise combination of the following:

**PEX\_LAST** This must be set on the last program in the pipeline. In particular, it should be set when executing a single program. The standard output of the program will be sent to *outname*, or, if *outname* is NULL, to the standard output of the calling program. Do *not* set this bit if you want to call pex\_read\_output (described below). After a call to pex\_run with this bit set, pex\_run may no longer be called with the same *obj*.

#### PEX\_SEARCH

Search for the program using the user's executable search path.

#### PEX\_SUFFIX

outname is a suffix. See the description of outname, below.

PEX\_STDERR\_TO\_STDOUT

Send the program's standard error to standard output, if possible.

## PEX\_BINARY\_INPUT PEX\_BINARY\_OUTPUT PEX\_BINARY\_ERROR

The standard input (output or error) of the program should be read (written) in binary mode rather than text mode. These flags are ignored on systems which do not distinguish binary mode and text mode, such as Unix. For proper behavior these flags should match appropriately—a call to pex\_run using PEX\_BINARY\_OUTPUT should be followed by a call using PEX\_BINARY\_INPUT.

#### PEX\_STDERR\_TO\_PIPE

Send the program's standard error to a pipe, if possible. This flag cannot be specified together with PEX\_STDERR\_TO\_STDOUT. This flag can be specified only on the last program in pipeline.

executable is the program to execute. argv is the set of arguments to pass to the program; normally **argv**[0] will be a copy of executable.

*outname* is used to set the name of the file to use for standard output. There are two cases in which no output file will be used:

- 1. if PEX\_LAST is not set in *flags*, and PEX\_USE\_PIPES was set in the call to pex\_ init, and the system supports pipes
- 2. if PEX\_LAST is set in flags, and outname is NULL

Otherwise the code will use a file to hold standard output. If PEX\_LAST is not set, this file is considered to be a temporary file, and it will be removed when no longer needed, unless PEX\_SAVE\_TEMPS was set in the call to pex\_init.

There are two cases to consider when setting the name of the file to hold standard output.

- 1. PEX\_SUFFIX is set in flags. In this case outname may not be NULL. If the tempbase parameter to pex\_init was not NULL, then the output file name is the concatenation of tempbase and outname. If tempbase was NULL, then the output file name is a random file name ending in outname.
- 2. PEX\_SUFFIX was not set in *flags*. In this case, if *outname* is not NULL, it is used as the output file name. If *outname* is NULL, and *tempbase* was not NULL, the output file name is randomly chosen using *tempbase*. Otherwise the output file name is chosen completely at random.

errname is the file name to use for standard error output. If it is NULL, standard error is the same as the caller's. Otherwise, standard error is written to the named file.

On an error return, the code sets **\*err** to an **errno** value, or to 0 if there is no relevant **errno**.

On error the return value is -1, otherwise it returns the number of characters that would have been printed had n been sufficiently large, regardless of the actual value of n. Note some pre-C99 system libraries do not implement this correctly so users cannot generally rely on the return value if the system version of this function is used.
- int waitpid (int pid, int \*status, int) [Supplemental] This is a wrapper around the wait function. Any "special" values of pid depend on your implementation of wait, as does the return value. The third argument is unused in libiberty.
- int writeargv (char \* const \*argv, FILE \*file) [Extension] Write each member of ARGV, handling all necessary quoting, to the file named by FILE, separated by whitespace. Return 0 on success, non-zero if an error occurred while writing to FILE.
- char\* xasprintf (const char \*format, ...) [Replacement] Print to allocated string without fail. If xasprintf fails, this will print a message to stderr (using the name set by xmalloc\_set\_program\_name, if any) and then call xexit.
- int xatexit (void (\*fn) (void)) [Function] Behaves as the standard atexit function, but with no limit on the number of registered functions. Returns 0 on success, or -1 on failure. If you use xatexit to register functions, you must use xexit to terminate your program.

[Supplemental]

- void\* xcalloc (size\_t nelem, size\_t elsize) [Replacement] Allocate memory without fail, and set it to zero. This routine functions like calloc, but will behave the same as xmalloc if memory cannot be found.
- void xexit (int code)

[Replacement] Terminates the program. If any functions have been registered with the **xatexit** replacement function, they will be called first. Termination is handled via the system's normal exit call.

- void\* xmalloc (size\_t) [Replacement] Allocate memory without fail. If malloc fails, this will print a message to stderr (using the name set by xmalloc\_set\_program\_name, if any) and then call xexit. Note that it is therefore safe for a program to contain **#define malloc xmalloc** in its source.
- void xmalloc\_failed ( $size_t$ ) [Replacement] This function is not meant to be called by client code, and is listed here for completeness only. If any of the allocation routines fail, this function will be called to print an error message and terminate execution.
- [Replacement] void xmalloc\_set\_program\_name (const char \*name) You can use this to set the name of the program used by xmalloc\_failed when printing a failure message.
- void\* xmemdup (void \*input, size\_t copy\_size, size\_t alloc\_size) [Replacement] Duplicates a region of memory without fail. First, alloc\_size bytes are allocated, then copy\_size bytes from input are copied into it, and the new memory is returned. If fewer bytes are copied than were allocated, the remaining memory is zeroed.
- void\* xrealloc (void \*ptr, size\_t size) [Replacement] Reallocate memory without fail. This routine functions like realloc, but will behave the same as **xmalloc** if memory cannot be found.
- char\* xstrdup (const char \*s) [Replacement] Duplicates a character string without fail, using xmalloc to obtain memory.
- char\* xstrerror (int errnum) [Replacement] Behaves exactly like the standard strerror function, but will never return a NULL pointer.
- char\* xstrndup (const char \*s, size\_t n) [Replacement] Returns a pointer to a copy of s with at most n characters without fail, using xmalloc to obtain memory. The result is always NUL terminated.
- char\* xvasprintf (const char \*format, va\_list args) [Replacement] Print to allocated string without fail. If xvasprintf fails, this will print a message to stderr (using the name set by xmalloc\_set\_program\_name, if any) and then call xexit.

#### A.1.1 Preamble

The licenses for most software are designed to take away your freedom to share and change it. By contrast, the GNU General Public Licenses are intended to guarantee your freedom to share and change free software—to make sure the software is free for all its users.

This license, the Lesser General Public License, applies to some specially designated software—typically libraries—of the Free Software Foundation and other authors who decide to use it. You can use it too, but we suggest you first think carefully about whether this license or the ordinary General Public License is the better strategy to use in any particular case, based on the explanations below.

When we speak of free software, we are referring to freedom of use, not price. Our General Public Licenses are designed to make sure that you have the freedom to distribute copies of free software (and charge for this service if you wish); that you receive source code or can get it if you want it; that you can change the software and use pieces of it in new free programs; and that you are informed that you can do these things.

To protect your rights, we need to make restrictions that forbid distributors to deny you these rights or to ask you to surrender these rights. These restrictions translate to certain responsibilities for you if you distribute copies of the library or if you modify it.

For example, if you distribute copies of the library, whether gratis or for a fee, you must give the recipients all the rights that we gave you. You must make sure that they, too, receive or can get the source code. If you link other code with the library, you must provide complete object files to the recipients, so that they can relink them with the library after making changes to the library and recompiling it. And you must show them these terms so they know their rights.

To protect each distributor, we want to make it very clear that there is no warranty for the free library. Also, if the library is modified by someone else and passed on, the recipients should know that what they have is not the original version, so that the original author's reputation will not be affected by problems that might be introduced by others. Finally, software patents pose a constant threat to the existence of any free program. We wish to make sure that a company cannot effectively restrict the users of a free program by obtaining a restrictive license from a patent holder. Therefore, we insist that any patent license obtained for a version of the library must be consistent with the full freedom of use specified in this license.

Most GNU software, including some libraries, is covered by the ordinary GNU General Public License. This license, the GNU Lesser General Public License, applies to certain designated libraries, and is quite different from the ordinary General Public License. We use this license for certain libraries in order to permit linking those libraries into non-free programs.

When a program is linked with a library, whether statically or using a shared library, the combination of the two is legally speaking a combined work, a derivative of the original library. The ordinary General Public License therefore permits such linking only if the entire combination fits its criteria of freedom. The Lesser General Public License permits more lax criteria for linking other code with the library.

We call this license the *Lesser* General Public License because it does *Less* to protect the user's freedom than the ordinary General Public License. It also provides other free software developers Less of an advantage over competing non-free programs. These disadvantages are the reason we use the ordinary General Public License for many libraries. However, the Lesser license provides advantages in certain special circumstances.

For example, on rare occasions, there may be a special need to encourage the widest possible use of a certain library, so that it becomes a de-facto standard. To achieve this, non-free programs must be allowed to use the library. A more frequent case is that a free library does the same job as widely used non-free libraries. In this case, there is little to gain by limiting the free library to free software only, so we use the Lesser General Public License.

0. A "work based on the Library" means either the Library or any derivative work under copyright law: that is to say, a work containing the Library or a portion of it, either verbatim or with modifications and/or translated straightforwardly into another language. (Hereinafter, translation is included without limitation in the term "modification".)

"Source code" for a work means the preferred form of the work for making modifications to it. For a library, complete source code means all the source code for all modules it contains, plus any associated interface definition files, plus the scripts used to control compilation and installation of the library.

Activities other than copying, distribution and modification are not covered by this License; they are outside its scope. The act of running a program using the Library is not restricted, and output from such a program is covered only if its contents constitute a work based on the Library (independent of the use of the Library in a tool for writing it). Whether that is true depends on what the Library does and what the program that uses the Library does.

1.
