### For BS Zoology

- All candidate must have Domicil of Punjab.
- The maximum age limit of the candidate is 20 years However the age may be relaxed up to 4 years by the Competent Authority.
- The Candidates must have 45% marks in F.Sc (Pre-medical) or equivalent (i.e. A Level Intermediate) in 2<sup>nd</sup> Annual examination and 1<sup>st</sup> annual 2020. However candidates of the earliest session may be considered by deducting 10 marks for each year for Replica programs only.
- Admission will be granted provisionally subject to verification of the certificates of the candidates from the relevant Secondary Board. Equivalence certificate is required from IBCC (Islamabad) where applicable.

### For M.Sc Zoology

- Male/female candidates having domicile of only Punjab are eligible for admission.
- The candidates shall be eligible to apply for admission, who have
  - o At least 45% marks in terminal degree
  - o At least 45% marks in the major subject (Zoology) in which admission is being sought.
- The candidates who have passed B.Sc or equivalent examination in 2019 and 2018 will be considered for admission. However, candidates of earlier sessions will be considered by deducting 10 marks for each year for admission subject to availability of seats after accommodating fresh candidates.
- The maximum age limit is 28 years on the closing date of applications for Master programmes. However age relaxation may be granted in special cases up to 05 years by the Competent Authority (i.e. upto 2 years by the Principal of the college & more than that by the Vice Chancellor of GCU) subject to availability of seats after accommodating fresh candidates.

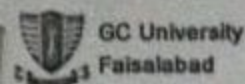
