Riverside Healthcare is a multi-site healthcare service in Kankakee, Illinois. It operates as a not-for-profit professional medical centre, servicing around 350,000 patients each year. As a whole, the service provides facilities such as senior living, cancer treatment, specialised surgery, neurology and orthopaedic care.

The site is also home to 450 'guest workers' - a variety of doctors and other medical workers using the facilities. In total, there are around 2,400 employees and clients who serve as staff.

Protection of sensitive data is paramount. Patients' private medical records, along with credit card information, are integral to the organisation's workflow. A data breach of any kind could be a major catastrophe for Riverside, which operates within tight compliance parameters. Performance is key as even tiny delays could seriously impact patient health.

## SATISFACTION CORRELATES TO INCOME

Patient satisfaction is absolutely critical to the success of Riverside Healthcare. Two major governmental services – Medicare and Medicaid – base their payments to Riverside on this metric. These payments represent an enormous proportion of the Riverside's income.

Commerce also plays a role, with on-site pharmacies and healthcare supplies offered in dedicated retail space. IT security is particularly crucial for this area, with confidential patient information and credit card data needing protection.

The catchment area for Riverside Healthcare is vast, over 80 miles in diameter. The facilities are located across three counties and over 300 physicians are part of the staff.

The specialities Riverside offer, are highly demanding; diabetes management, stroke care, neurosurgery, endocrinology, radiology, rehabilitation and rheumatology are among the services offered. The Emergency Department is designated as a Level II Trauma Centre, serving medical, surgical and traumatic emergencies.

### CHALLENGE:

With increasing demands and more critical situations, Riverside needed to be assured that it would be on top of security threats, especially with growing staff numbers. When new machines and devices were used, the existing anti-virus (AV) system did not detect them. Many workers were dissatisfied, as the software was the cause of around 100 staff complaints every year due to it negatively affecting computer performance. Medical and credit card data needed higher protection for compliance and privacy reasons.

### SOLUTION:

Six AV vendors were reviewed. Features assessed were encryption, application control and endpoint management. "I wanted more than just anti-virus" says Erik Devine, CSO of Riverside Healthcare. Kaspersky fulfilled all these needs, covering a wider area than its predecessor. The deployment consists of Kaspersky Endpoint Security for Business (Advanced); Kaspersky Security for Microsoft Exchange Servers and Kaspersky Security for Virtualization.
