## Right to Object to New Subprocessor:

Krisp shall specifically inform the Customer in writing of any intended changes to the list of Subprocessors through the addition or replacement of Subprocessors at least 20 days in advance, thereby giving the Customer sufficient time to be able to object to such changes prior to the engagement of the Subprocessor(s). A Customer may object to Krisp's use of a new Subprocessor by notifying Krisp promptly in writing within ten (10) business days after receipt of Krisp's notice in accordance with the mechanism set out above. If you object to a new Subprocessor, and that objection is not unreasonable, Krisp will use reasonable efforts to make available to you a change in the applicable Service or recommend a commercially reasonable change to your configuration or use of the applicable Service to avoid processing of personal data by the objected-to new Subprocessor without unreasonably burdening you. If Krisp is unable to make available such change within a reasonable time, which shall not exceed thirty (30) days, you may terminate the applicable Order Form(s) with respect only to those Service(s) which cannot be provided by Krisp without the use of the objected-to new Subprocessor by sending an email notice to dpo@krisp.ai.

The absence of written Subprocessor objection from your side within 10 business days after receiving notification from us will constitute your agreement to the Subprocessor list herein.
