



Additional Licensor Product- specific Terms:

Further, pre-approval (phases 1-3) and post-approval (phase 4) clinical trials, operational data on trial execution, safety risk monitoring (pre and post marketing pharmacovigilance), and adverse event tracking are specifically included in the CRM, while outcomes research, health economics, and management of clinical operations are specifically excluded from the CRM.
