### American Public University System (APUS) BS Accounting

Students must complete a minimum of 120 semester hours (either by transfer or completion at APUS) to complete the Bachelor of Science in Accounting. This transfer pathway recommends completing 81 credits at the Maricopa Community Colleges, followed by 39 credits at APUS as listed below.

## **Associate of Applied Science in Accounting**

### Complete the AAS Accounting (Major Code 3149) as prescribed

When options are available, APUS recommends: COM 225, ECN 211 or ECN 212, GBS 120 or GBS 233, ACC 112, ACC 221, ACC 222

One additional Social-Behavioral Sciences Option course

Any 150 level MAT course (APUS recommends MAT 152) <u>Note:</u> MAT 187 is not a recommended alternative because APUS requires College Algebra and College Trigonometry to be taken separately.

- In order to transfer courses to APUS, the student must earn a grade of "C" or better.
- APUS must adhere to the residential credit requirements and corresponding transfer credit limits set forth by the Higher Learning Commission (HLC). At least 25% of the degree program must be completed as residential credit. For a Bachelor's degree with 120 semester hours, 30 of those semester hours must be residential credit.
