In this month, we have seen significant strides in research related to understanding and treating COVID-19. CSRD investigators have been starting new studies focused on bringing forth solutions to the pandemic. We believe the data will be transformed SQL tables with linking variables added and provided as cohort data views or extracts For DART approved research projects by VINCI, the data will be made available. Many researchers have been asking for the types of data included in the USVETS dataset. Within a short time the files should be added to DART and available for research use.
