## **Demanding Biden’s FDA Stop Treating COVID Based on Race**

Also this week, I authored a [letter to FDA Acting Commissioner Dr. Janet Woodcock](#), along with 30 of my House colleagues. The letter demands Biden’s FDA withdraw its unconstitutional guidance that calls for healthcare professionals to administer monoclonal antibody treatment on the basis of race.

The decision whether to prescribe life-saving monoclonal antibody treatments should be made based on medical need, but the Biden Administration has other ideas. Discriminating who receives treatment based on race violates the 14th Amendment and is simply un-American.
