In the Declaration of Independence, our founders declared that there are certain unalienable rights guaranteed to all individuals. Among these is the right to life. There is nothing more precious or foundational than protecting life.

Congressional Democrats and radical leftist organizations sadly don't see it that way. According to them, killing a child is a better alternative than giving that child a chance, no matter what his or her circumstances might be.
