This week, *POLITICO* leaked a draft Supreme Court decision revealing that a majority of the Court's Justices are in favor of striking down *Roe v. Wade* after nearly 50 years of horror. 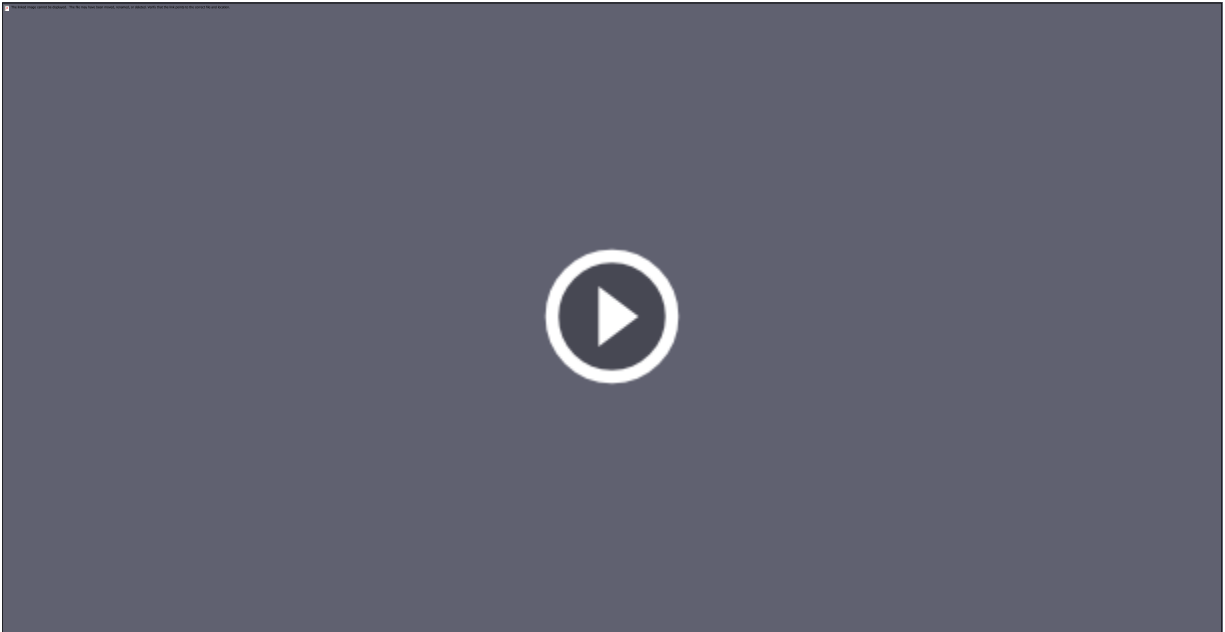
