Dear Friends,

This week in Washington, Democrats, led by Speaker Pelosi, showed their true colors through a number of partisan power grabs. Speaker Pelosi refused to accept Republican Leader Kevin McCarthy's nominations to the Speaker's January 6th Select Committee. My colleagues, Rep. Jim Banks and Rep. Jim Jordan, are highly respected Members of Congress who will ask the tough questions, but Speaker Pelosi chose to appease her radical base by rejecting them. This kind of toxic leadership is the very reason many of my colleagues and I opposed creating a commission in the first place.

It's clear that scoring political points is the Democrats' top priority these days. Before even beginning to assess the facts surrounding the events of January 6th, the Speaker's Select Committee already proved itself to be another source of partisan theatrics disguised as an impartial investigation. There is no legitimate reason to oppose Republican appointments other than a fear that they will ask questions and not go along with a predetermined narrative.

Unfortunately, the Democrats' power grabs didn't end there. Recently, White House Press Secretary Jen Psaki unabashedly revealed that the Biden administration is flagging "problematic" posts to Facebook and encouraging Big Tech firms to remove Americans' content from the public square. Every American should be gravely concerned that the executive branch is colluding with Big Tech companies to censor speech the administration dislikes. [I joined a letter with Rep. Jordan](#) and House Judiciary Republicans demanding that President Biden direct his administration to immediately end this chilling practice.

Make no mistake: I am concerned first and foremost about meeting American citizens' needs. This country belongs to you – not to the elites, not to the criminals shooting up our cities, and not to illegal immigrants. I will continue to speak out on behalf of my constituents who are increasingly frustrated with the way their country is being governed.

Following more than 35,000 comments to the department, included a comment I filed, the Department rescinded this effort. In the end, we will defeat this form of neo-racism, and that will be thanks to mom and dads in North Carolina and across America speaking up for what's right.
