In a total of 221 projects, 101 are international productions /co-productions (from Europe, Asia, United States, Canada, and Australia). More than 51,400 jobs were created for production needs, in 140 different locations across Greece. "Particularly in 2021, more than 10 high budget productions were shot in Greece

(for Amazon, Netflix, Paramount Studios, Ap-

ple TV, Millenium Films), as a result of the

very competitive investment incentive and

tax incentive for a/v production that Greece offers (40% cash rebate and 30% tax relief) explained Kouanis. The major selling point concerns productions with eligible expenses over 8 million euros in Greece, that provides the ability for subsidies on non-resident labor (e.g., for scriptwriter and director fees salaries of cast and crew for feature films and TV series or expenses for copyright to use images for cultural and educational games)

"Despite the impediments of the pandemic worldwide, 2021 proved to be very productive year for the a/v sector in Greece. Given all our efforts and the results so far in EKOME, we are very optimistic that in the coming years, Greece will become one of the top filming destinations in Europe" Kouanis concluded
