CW5 Hughes enlisted in the Army in May 1991 and completed Advanced Individual Training as a 35G (Bio-Medical Equipment Technician) at Fitzsimons Army Medical Center, CO. In 2004 she was selected into the 670A Health Services Maintenance Warrant Officer Program and graduated Warrant Officer Candidate School in March 2005.
