To make Rules for the Government and Regulation of the land and naval Forces;

To provide for calling forth the Militia to execute the Laws of the Union, suppress Insurrections and repel Invasions;

To provide for organizing, arming, and disciplining, the Militia, and for governing such Part of them as may be employed in the Service of the United States, reserving to the States respectively, the Appointment of the Officers, and the Authority of training the Militia according to the discipline prescribed by Congress;

To exercise exclusive Legislation in all Cases whatsoever, over such District (not exceeding ten Miles square) as may, by Cession of particular States, and the acceptance of Congress, become the Seat of the Government of the United States, and to exercise like Authority over all Places purchased by the Consent of the Legislature of the State in which the Same shall be, for the Erection of Forts, Magazines, Arsenals, dock-Yards, and other needful Buildings; And

To make all Laws which shall be necessary and proper for carrying into Execution the foregoing Powers, and all other Powers vested by this Constitution in the Government of the United States, or in any Department or Officer thereof.

INTRODUCTION OF THE WASHINGTON, D.C. AREA HELICOPTER NOISE INFORMATION EXCHANGE ACT OF 2021

Ms. NORTON. Madam Speaker, today, I introduce the Washington, DC Area Helicopter

Noise Information Exchange Act of 2021, which would require the Federal Aviation Administration (FAA) to implement a Government Accountability Office (GAO) recommendation to create a mechanism to exchange information about helicopter noise in the Washington, DC area between FAA and helicopter operators. I am pleased that Representatives GERALD E. CONNOLLY and DONALD S. BEYER, Jr. from Virginia and Representatives JAMIE RASKIN, ANTHONY G. BROWN and DAVID J. TRONE from Maryland join me in introducing this bill, underscoring its regional importance.

Residents of the District of Columbia and the national capital region (NCR) have been plagued by helicopter noise for years. Yet, there is no centralized complaint system nor any comprehensive data about helicopter noise in the NCR. In January 2019, Representatives CONNOLLY, BEYER, RASKIN, BROWN, TRONE and I wrote GAO requesting that it conduct a study of helicopter noise in the NCR. In that letter, we wrote, "Many of our constituents live with the impacts of regular helicopter noise that interrupts sleep patterns, causes their homes to shake and negatively impacts their quality of life. While disturbances from helicopter noise have been a longstanding problem for some, others have noted recent increases in the frequency and severity of helicopter noise in their neighborhoods. We understand that helicopter activity is an essential part of law enforcement, military and medical operations and appreciate the critical efforts of employees serving in those sectors. However, we also believe that, through information collection, analysis and coordination, we can identify strategies to minimize the negative impacts of helicopter activity without impeding the work of the agencies operating helicopters within the region."

In response to our request, GAO announced in June 2019 that it would conduct the study. GAO released its report in January 2021. GAO found that FAA's current ability to work with helicopter operators in the NCR is limited because of the absence of effective information sharing mechanisms. GAO recommended that FAA direct its Office of Environment and Energy to develop a mechanism to exchange helicopter noise information with operators in the NCR. FAA concurred with GAO's recommendation, but this bill would require FAA to develop such a mechanism.

This bill would direct the creation of a more effective information sharing mechanism, which would also allow for better, more comprehensive data on helicopter noise complaints. This data would in turn help us develop solutions to address helicopter noise.

I urge my colleagues to support this bill.

HONORING THE LIFE OF HERMON RUDOLPH NETHERLAND

Mr. BABIN. Madam Speaker, I rise today to honor the life of Hermon Rudolph Netherland, who passed away on Friday, March 19, 2021, at the age of 94. Hermon was a U.S. Navy World War II veteran, longtime resident of Tyler County, and deeply respected by all who knew him.

Hermon was born on April 21, 1926, in Enterprise, Louisiana, to Anne and Neal Netherland. At a young age, his family moved to Port Arthur, where he was raised. Like many kids of his generation, Hermon worked from an early age. His family had a large garden and they grew an assortment of fruits and vegetables from bell peppers to cantaloupes. Hermon had the responsibility of tending the garden. His duties included hoeing, watering, and picking the vegetables. At the onset of WWII, Hermon felt led to serve his country and wanted to enlist. However, Hermon's father was against this decision, fearing his 15-year-old son would go to war. After spending the next year convincing his father, Hermon was finally allowed to enlist in the Navy.

After completing Basic Training in San Diego, California, and signal school in Chicago, Illinois, Hermon enrolled in underwater demolition training at Fort Pierce in Florida. He soon qualified as both a Navy signal man and frog man, (someone who assisted with underwater demolitions). After a deployment in Newport, Rhode Island, Hermon went on to participate in nearly every major campaign in the Pacific Theater. Throughout the war, he would be based on the USS *Birgit*, a troop transport and cargo ship. His duties would rotate between signalman, frog man, and manning a landing craft taking troops to shore on several of the most dangerous invasion campaigns. Hermon was present for the U.S. invasion of Guam, Sai Pan, Iwo Jima, Okinawa, the Philippines, and the Marshall Islands. While in the Philippines, Hermon and fellow Navy frogmen were tasked with helping to open the Straits of Hormuz.

The USS *Birgit* returned to America after the war via the Panama Canal. Conveniently, its final stop was the Port of Orange, where the ship was then decommissioned and sold. Essentially, the ship he had spent the entirety of the war on, traveling across the Pacific Ocean, delivered Hermon to his own front door. Shortly after returning home, Hermon met Velma, the love of his life. They were married soon after she completed high school. They were blessed with 64 years of marriage and a wonderful baby girl. Following his time in the military, Hermon went to work for Texaco in Port Arthur and retired from there after many years of service. During his retirement, Hermon enjoyed spending time at his cabin located on Lake Amanda in Colmesneil to hunt and fish.
