While the school has remained committed to its core values, Le Moyne has always prided itself on being a trailblazer for progress. At the time of its founding in 1946, Le Moyne was the first Jesuit college in the United States to open as a coeducational institutional. And in 2014, Linda LeMura was named the college's 14th president, making her the first female layperson to lead a Jesuit institution in the United States. Under her leadership, President LeMura has raised the college's profile, prioritized inclusivity, and worked to foster an environment where Le Moyne students and faculty can learn and grow. Notably, during the pandemic, President LeMura took an unusual step to limit the spread of COVID-19 amongst the school's population and highlight the importance of being a thoughtful steward of the community by moving into a neighborhood popular with students living off-campus. For several months, LeMura became a friendly face in the neighborhood. She greeted students living nearby on her daily walks, helped them keep their lawns free of trash and debris, and reprimanded those holding gatherings that could spread the virus.

Le Moyne consistently encourages students to put Jesuit values in action by providing volunteer opportunities within Central New York and around the world, and harboring extensive networks at local non-profits, shelters, kitchens, and schools. In 2020, Le Moyne launched its Erie 21 program, which helps veterans, immigrants, refugees, the underemployed and unemployed obtain internships and software development jobs with local employers by providing students with technical and computer coding skills. The impact Le Moyne students have had in our Central New York community and around the world is both far-reaching and impactful. It is exemplified by alumni like Jeanette Epps, the first Black female astronaut to serve as a crewmember on the International Space Station, who is conducting research that will benefit all of mankind. And Andrew Lunetta, who found his passion helping homeless individuals and families in Central New York while at Le Moyne, and has since founded Tiny Home For Good, a nonprofit that builds safe and affordable housing for those less fortunate.

Mr. SOTO. Madam Speaker, Seminoles have called Florida home for thousands of years. Their ancestors met the Spanish when they touched down on Florida's shores in 1510 and created a refuge for those who sought to escape slavery and oppression. In 1830, when President Andrew Jackson broke the treaties he signed with native peoples and ordered those east of the Mississippi River be "removed" west, the Seminoles resisted and fought for their freedom alongside their neighbors. They kept their ways and traditions alive in the Everglades of Florida, where they remain free and unconquered to this day.

Facing the threat of the termination of services and Federal assistance in the 1950's the Seminole Tribe of Florida organized to develop a constitution, advanced through meetings under the old Council Oak Tree on the Hollywood Reservation. Federal recognition in 1957 reinforced the inherent sovereignty and necessitated a new form of self-governance for the newly organized Tribe. As more outsiders came to Florida, the Tribe adapted and developed new economic opportunities, including tourism enterprises and cattle operations.

Today, the Tribe counts over 4,000 members. They are a sovereign government, with their own schools, police, and courts. Members continue their traditions of sewing, patchwork, chickee building, and alligator wrestling but the Seminole Tribe also adapted to a changing world. Today, they run one of the largest cattle operations in the United States and own the Hard Rock Hotel & Casinos, an international business with locations in 74 countries.

The Seminole Tribe also gives back to its community and is actively helping to protect the Everglades they call home. The Seminole Tribe has been actively involved in the Ever-

glades restoration effort since its inception and has contributed significant resources to ensure that the overall restoration effort is successful, while protecting its sovereignty and unique way of life. For all this and more, we honor The Seminole Tribe of Florida for National Native American Heritage Month.

Mr. HUDSON. Madam Speaker, I rise, along with my colleague, Congressman STEVE COHEN, fellow co-chair of the Congressional Caucus on Global Road Safety, to mark the 26th World Day of Remembrance for Road Traffic Victims (World Day) on Sunday, November 21, 2021.

On this solemn event, families, advocates, and leaders around the world gather to remember the tens of millions of lives impacted by road crashes and the bravery of the first responders and health care workers who work valiantly to save as many lives as possible.

World Day of Remembrance was initiated in 1995 as the European Day of Remembrance and quickly spread around the globe. In 2005 the United Nations General Assembly adopted Resolution 60/2, recognizing the third Sunday in November as the World Day of Remembrance for Road Traffic Victims.

Every year, the goals of the World Day of Remembrance are to remember all people killed and seriously injured on the roads; acknowledge the crucial work of the emergency services; advocate for better support to road traffic victims and their families; and promote evidence-based actions to prevent and eventually stop further road traffic deaths and injuries.

More than one million people die from road crashes every year, and tens of millions are seriously injured. Road traffic crashes are the number one killer of young people aged 15–29, the third leading killer of Americans abroad, and the eighth leading cause of death among all people worldwide. Despite these figures, our understanding of the full scope of the problem is still lacking, and additional data collection is imperative.

World Day of Remembrance 2021 also focuses on reduction of traffic speeds. Studies

have shown unequivocally that lowering speeds has the potential to prevent many deaths and serious injuries, in particular those of pedestrians and all other vulnerable road users like children, people with disabilities, and the elderly.

This year also marks the beginning of the second global Decade of Action for Road Safety 2021–2030, which has a primary goal of reducing the number of deaths and serious injuries caused by road traffic accidents by at least 50 percent by 2030. Additionally, in October 2021, Congressman COHEN and I officially relaunched the Congressional Caucus on Global Road Safety, working closely with the Association for Safe International Road Travel (ASIRT), the leading U.S. nonprofit advocating for safe travel on the world’s roads.

Rochelle Sobel founded ASIRT in response to the death of her son Aron, a 22-year-old medical student who was killed in a bus crash in Turkey along with 23 other passengers. ASIRT works to improve the safety of travelers through education and advocacy and was instrumental in encouraging the establishment of the Caucus in 2004.

Looking ahead to what we must accomplish in this second Decade of Action, it is crucial that we collaborate to enact common sense solutions to meaningfully reduce the terrible toll of road crashes. We know how to save lives, now we must muster the will and courage to act with conviction.

As Co-Chairs of the Congressional Caucus on Global Road Safety, we implore our colleagues, partners, stakeholders, industry leaders and decision-makers worldwide to heed the message of World Day to “remember, support, and act” to improve road safety and prevent avoidable tragedies. We look forward to welcoming more of our colleagues to the Caucus and working in earnest to provide leadership and make tangible advances to reduce road deaths.

One year later, Richard enlisted into the Army where he served as a marine engine mechanic. After leaving the Army and working in a car factory, Richard re-enlisted and served in the Korean War. He was seriously wounded during the war, and was awarded the Purple Heart.

After being discharged as a Sergeant First Class, Richard relocated to Los Angeles in 1953 and entered public service with the Sheriffs Department and then as an investigator with the District Attorney's office. He attended law school at night at Pacific Coast University while working in law enforcement during the day. Upon passing the bar, he worked as the Assistant County Counsel for Butte County. He later returned to Los Angeles where he met Judith Wallingford and married her in 1970.

Richard's experience and success as a trial lawyer led him to be recruited to the District Attorney's office. From 1975 to 1998, Richard served as a Juvenile Court Referee and then as a Superior Court Judge on the Santa Barbara County Superior Court.

In retirement, Richard dedicated his time to his art, family, and traveling with his beloved wife. Richard was a dedicated husband, loyal friend, and selfless public servant. He will be fondly remembered by his loved ones, friends, colleagues, and community.

GETTYSBURG ADDRESS

PRESIDENT ABRAHAM LINCOLN—NOVEMBER 19, 1863

"Fourscore and seven years ago our fathers brought forth, on this continent, a new nation, conceived in liberty, and dedicated to the proposition that all men are created equal. Now we are engaged in a great civil war, testing whether that nation, or any nation so conceived, and so dedicated, can long endure. We are met on a great battlefield of that war. We have come to dedicate a portion of that field, as a final resting place for those who here gave their lives, that that nation might live. It is altogether fitting and proper that we should do this. But, in a larger sense, we cannot dedicate, we cannot consecrate—we cannot hallow—this ground. The brave men, living and dead, who struggled here, have consecrated it far above our poor power to add or detract. The world will little note, nor long remember what we say here, but it can never forget what they did here. It

is for us the living, rather, to be dedicated here to the unfinished work which they who fought here have thus far so nobly advanced. It is rather for us to be here dedicated to the great task remaining before us—that from these honored dead we take increased devotion to that cause for which they here gave the last full measure of devotion—that we here highly resolve that these dead shall not have died in vain—that this nation, under God, shall have a new birth of freedom, and that government of the people, by the people, for the people, shall not perish from the earth."

Mr. NORMAN. Madam Speaker, I rise today to honor and recognize the service of Master Sergeant Harold Shoepflin of South Carolina. A true American hero, Harold bravely served our country throughout World War II, the Korean War, and the Vietnam War. In 1943, he enlisted in the Navy and was sent to Camp Perry, Virginia where he was assigned to a newly commissioned 72nd Construction Battalion. The battalion soon boarded a ship in Norfolk before heading to Pearl Harbor. In Hawaii, the battalion constructed runways, Quonset Huts, and a fuel tank field for the Navy and Marine Corps. Harold lost several close friends during the attack on Pearl Harbor. He also lost his brother, Bob, who was killed in action in Guam.

Despite these losses, following World War II, Harold enlisted in the Marine Corps. From there, he went through Parris Island, Camp Lejeune, and Camp Pendleton. When the Korean War erupted, Harold endured Marine Corps Cold Weather Mountain training and then traveled to Japan with the 1st Armored Amphibious Battalion.

After serving in Inchon during the Korean War, Harold returned to California where he spent several years at Camp Pendleton with the 7th Marine Engineers, attending various Leadership Schools.

Following the outbreak of the Vietnam War, Harold's battalion shipped out on a landing ship tank heading for Da Nang. During his time in Vietnam, Harold was assigned to Iron Mountain, and was also in charge of Base Services Recovery in Chu Lai.

After these many dangerous tours, Harold retired as a Master Sergeant in 1971. As a testament to his exemplary military career, Harold amassed many notable honors and accolades, including the World War II Navy Occupation Service Medal, the World War II Victory Medal, the Navy Commendation Medal with Combat "V," the Presidential Unit Citation, the American Campaign Medal, and numerous others. Following his military service, Harold and his family retired to Charleston, South Carolina where he maintained a successful career in the insurance and real estate industry. He also owned and operated a shrimp boat. Harold enjoyed 49 years of blissful marriage to his beautiful wife Ruth until her passing in 1996. Together, the couple raised four wonderful children: Debra, Nancy, Joy, and Harold Jr. Their son Harold followed in his father's footsteps and went on to serve as a major in the Marine Corps.

On behalf of the 5th District of South Carolina, I thank Harold for his outstanding service. He has created a lasting legacy of duty, honor, and courage, and our nation is better for his sacrifice.

Since then, his passion and dedication has led him to aiding the daily operations of meteorologists across the state. His expertise in topography has proven essential to understanding and communicating to the public the importance of elevation temperature changes on our climate in Alabama.

During his time observing the weather in Hamilton, he saw the many ways our weather

can reach the extremes. Back in January of 1966, he recorded his record low temperature of  $-19$  degrees. This was the same day the state of Alabama set its record low temperature of  $-27$  degrees recorded at New Market in Madison County. On the other end of the meteorological spectrum, Mr. Pearce recorded his record high temperature in August of 2007. His recording station hit 109 degrees during a record setting heat and drought that impacted all of Alabama.

The National Weather Service is honored to have an observer such as Mr. Pearce on their side and presented him with the Lifetime Achievement Award on November 2, 2021.

Mr. Pearce was married to Rosemary Ritchie Pearce for more than six decades. She passed away in 2019.

They had two children, son Eddie Pearce III and daughter Shawn Armstrong.

I want to congratulate Mr. Pearce on this well-deserved achievement as he portrays a great example of the genuine, hard-working people who make up Alabama's 4th District. I want to wish him all the best and thank him for his service to his community, Marion County, and all of Alabama.
