



Mrs. DINGELL. Madam Speaker, I rise today to recognize Supervisor Andrew Linko on the occasion of his retirement from the Charter Township of Brownstown, Michigan, where he has served as supervisor for over a decade. His significant contributions to our community are worthy of commendation.

Supervisor Linko began his journey of service as a Construction Electrician in the U.S. Naval Reserves, where he served from 1983 until 1993. A graduate of Youngstown State University, Wayne State University, and Baker College, he studied labor, leadership, electrical engineering, and health and human services. An active member of his community from a young age, he has served in various volunteer positions in local politics in Ohio. He was first elected to the position of City Councilman in Warren, Ohio, where he served as chair of the health and welfare committee.

Supervisor Linko came to find his new home in Brownstown Township when he moved to Michigan in 1996 to work for Ford Motor Company. He worked at Ford until his retirement in 2021. A devoted member of the United Auto Workers, he was a Trustee at UAW Local 387 where he was a leader among his union brothers and sisters and showed his commitment to our auto industry. His experience as a leader in the labor movement inspired him to run for office and show people how workers should be treated. Supervisor Linko started out serving the township on the Zoning Board of Appeals. He became treasurer of the Board of Trustees in 2008 and was appointed Township Supervisor in 2010. He was subsequently reelected in 2012, 2016, and 2020. During his tenure, he has been a champion for public safety. As supervisor, he oversaw the completion of a \$6 million recreation campus. His accomplishments include reducing the township's carbon footprint, welcoming hundreds of new residents, encouraging economic investment, and delivering new jobs for the people of the township. Under his leadership, Brownstown Township has become one of the fastest growing communities in Wayne Coun-Supervisor Linko is a member of the Woodhaven-Brownstown Rotary and resides in Brownstown Township with his wife, Linda. Together they have two daughters and one granddaughter.

Madam Speaker, I ask my colleagues to join me in honoring Supervisor Andrew Linko. We are grateful for his years spent serving the citizens of Brownstown Charter Township. Andy is someone that I am proud to call a friend, and I have depended on him for advice, wisdom, and guidance for years. This legislation is critical to the protection our democracy. We must ensure that voters can safely and freely cast their ballots, stop partisan gerrymandering, and limit the influence of dark money in politics so that billionaires cannot buy elections.

Our country remains in the middle of a desperate fight for voting rights. State legislatures around the country have introduced

HONORING ROBYN DOBERNECKER AS IOWAN OF THE WEEK

Mrs. AXNE. Madam Speaker, I rise today to ask the House of Representatives to join me in recognizing Robyn Dobernecker as Iowan of the Week.

An lowa native, Robyn has had a passion for animals for as Long as she could remem-

ber. She got her start as a kennel attendant at age 18, working with animals who needed to be adopted. She rose up through the ranks and became a senior animal control officer. where she humanely took animals off the streets, got them fed and cleaned, and ready for adoption. She decided to broaden her horizons and work at a vet clinic to better understand animal medicine. Through this, she finally got into the Animal Rescue League (ARL) of Iowa, where she is now the intervention coordinator and is responsible for confiscating animals abused at facilities in the state of Iowa. She is also the official point of contact for the rescue efforts for over 500 dogs that were confiscated by a puppy mill breeder, who received one of the harshest penalties for animal welfare violations in USDA history.

After getting three complaints about dog abuse in the summer of 2021, Robyn decided to investigate. What she found was appalling-animals left alone, abused, and neglected. Finding these dogs had little to no water, no food, and inadequate shelter, she immediately called the lowa attorney general, whose authorization was required to get into the facility and confiscate the animals. With no response, she decided to go to the breeder's hearing, where the USDA and DOJ were prosecuting. Hearing that the breeder's trial will be delayed, Robyn barged into a room of the courthouse full of federal prosecutors for DOJ and said, "My name is Robyn, my job is to help animals get out of abusive homes. But to do what I do, I need your authorization and for you to get on board, and I need a restraining order so I can get ahold of these dogs." This was on a Friday. On that next Monday, DOJ reached out to her and asked if they could work with her to get these dogs out of the facility.

After coordinating with government agencies and other animal rescue organizations, she was able to rescue the first round of dogs on October 13th. Once the breeder officially surrendered on November 1st, Robyn went in with her team and was able to confiscate the rest of the 414 dogs-she got all of them out over the next two days. This difficult feat was catalyzed by Robyn's desire to make a difference for communities. To see those dogs' tails wag for the first time and being able to hug and kiss the puppies once they were all clean made the process of rescuing them worth it. While there is always more work to do to counter animal abuse, we can revel in the admirable work it takes to rescue those who are in harm's way.

through unfair trade practices, targeted subsidization, and excess production capacity. This playbook involves undercutting American industry, flooding the domestic markets with imports, distorting competition, and driving competition under.

Our trade laws allow American manufacturers to seek relief from the International Trade Commission only after they've sustained material injury from uncompetitive trading practices. The decline in American manufacturing shows these laws to be insufficient. How many dormant American factories could have been saved before unfairly subsidized imports flooded U.S. markets? How much wealth has been shipped overseas, only to come back in the form of goods that put American workers out of a job?

Last year, the United States Trade Representative testified before the Ways and Means Committee on the need for forward-looking trade laws that protect American industry from price dumping, unfair competition, and illegal subsidies. In many cases, we know non-market economies intend to undermine American workers and our nation's industrial base through unfair means—it is their stated policy.

The Nonmarket Economy Overcapacity Reform Act will give the United States the tools we need to protect American jobs from the looming and established threat of global excess capacity. This narrowly tailored bill gives the United States the right to proactively seek antidumping and countervailing duties in demonstrated instances of buildup in excess production capacity. By focusing on non-market economies, this bill seeks to preserve the beneficial and lawful competitive trading relations we have established with our allies and goodfaith trading partners around the globe.

Madam Speaker, the United States has a responsibility to protect our Nation's manufacturers from unfair trading practices. When put on a level playing field, I know American workers can outperform anyone in the world—we must support them. I urge my colleagues to support H.R. 6330, the Nonmarket Economy Overcapacity Reform Act.

He knew that this school opened doors for its students and relished in uplifting all who crossed his path. The ultimate educator, the world was his classroom. Those who knew him know of his tenacity, compassion, and sharp wit.

Madam Speaker, I ask my colleagues to join me in honoring the life of John McDonald, we are all thankful for his dedication to education and the labor movement. A trusted friend and confidante of mine and a giant in our community, our thoughts are with his wife. Denise, and his family at this time.
