THREAT FROM FENTANYL FLOWING OVER OUR SOUTHERN BORDER

Mr. GOSAR. Madam Speaker, I rise today to address a catastrophic mass death in our country because of our open borders—all due to fentanyl.

Fentanyl is freely flowing across our southern border as seizures increased by nearly 135 percent in 2021 under Joe Biden's lax immigration enforcement.

In FY 2021, Customs and Border Protection seized 11,201 pounds of fentanyl, a historic rate that is more than all that was seized in 2018 and 2019 combined. This amounts to enough fentanyl to cause 2,540,341,996 deaths, or more than 7 times the U.S. population.

The free flow of this deadly drug across our border is a direct result of the Biden administration's open border policies. The fact is, Joe Biden continues to ignore and fails to address the record high overdose deaths caused from deadly fentanyl-related substances crossing our border.

As a result, the scourge of fentanyl is destroying our communities, killing our children and devastating our families.

According to the Drug Enforcement Administration (DEA), U.S. overdose deaths reached a devastating new height in 2021, claiming a new victim every five minutes.

There is a direct link between fentanyl-related overdose deaths and criminal drug cartels in Mexico. The ease in which the drug cartels operate is shocking. The cartels control the borders and are taking full advantage of Joe Biden's weak immigration policies.

Last December, in my home state of Arizona, the Scottsdale Police Department and the Arizona Attorney General's Office seized a record 1.7 million fentanyl pills and 10 kilograms of fentanyl powder.

During a recent two-month public safety surge, the DEA Phoenix Field Division announced total seizures of over three million fentanyl pills and 45 kilograms of fentanyl powder.

Just one fentanyl pill can kill. Yet our open borders remain a fentanyl pipeline.

Instead of securing our southern border to stop the flow of fentanyl, Mr. Biden has doubled down on his open-border policies that will

only worsen the ongoing border crisis and destroy more communities and lives.

Just because Joe Biden ignores the fentanyl crisis doesn't mean Congress should. Congress must address the crisis at the border.

Congress must also take action and permanently place fentanyl-related substances in Schedule I of the Controlled Substances Act. The emergency class-wide scheduling order for fentanyl-related substances is set to expire on February 18, 2022.

Speaker PELOSI and the Democrats are wrong to allow this order to expire.

Julie worked as the RC&D Coordinator until November of 2009, when she accepted the position as Public Affairs Officer on the Sawtooth National Forest. In this role, she worked with Incident Management Teams throughout the country, grew and maintained the South-Central Idaho Resource Advisory Committee, built relationships between the Forest Service and the Idaho Congressional Delegation, was a leader in Forest Civil Rights, and was recognized in the Forest Service Intermountain Region as leader in employee deployment and engagement. Above all, Julie was a friend to all in the Forest Service. On December 31, 2021, Julie retired from the Forest Service after a 41-year career.

Mr. PALAZZO. Madam Speaker, I rise today to recognize the official renaming of the Gulfport Fitness Center in honor of Builder Chief Petty Officer Raymond Border.

Raymond Border was born on July 22, 1980, in Coshocton, Ohio. He enlisted in the Navy on September 22, 1999. Upon completion of Builder A-school Gulfport, MS BUC Border completed successful tours deploying twice with Naval Mobile Construction Battalion ONE. His daughter, Shelva Border and son Donovan Border currently still live in Gulfport. His father Craig Border and mother Julie Border live in West Lafayette, Ohio.

A few months after returning home from deployment in 2011 to Afghanistan's Helmand Province with Naval Mobile Construction Battalion 74 BUC Border volunteered for an Individual Augmentee billet on a Provincial Reconstruction Team and returned to Afghanistan, where he lost his life in the line of duty.

For his outstanding service, BUC Border was posthumously awarded the Bronze Star (with combat V), Purple Heart, and Combat Action Ribbon. He was awarded the Navy and Marine Corps Achievement Medal and the Navy Commendation Medal during his previous naval service.

Traditionally Seabee facilities are named after Seabees that have paid the ultimate sacrifice in the service of their country. BUC Border was killed when an improvised explosive device detonated while he was executing a road assessment for a convoy in Paktika Province, Afghanistan, on October 19, 2011.

This total force effort of active and reserve airmen directly enabled the largest non-combatant evacuation operation in known world history, ultimately saving over 124,000 lives. Simply put, Travis Air Force Base is the very best our nation has to offer. Its strategic importance stands as a beacon of hope to our allies and a stern reminder of American resolve to our enemies. Mr. SIMPSON. Madam Speaker, along with my colleagues Senator MIKE CRAPO and Senator JIM RISCH, I rise to call attention to the outstanding life of Stephen Anthony Hartgen, long-time editor and publisher of the Times-News in Twin Falls, Idaho, five-term Idaho



State legislator, community businessman, and Magic Valley cultural historian. Steve, as he was called by his family and friends, passed away on December 31, 2021, at 77 years old.

Steve was born on September 30, 1944 in Baltimore, Maryland, one of twin sons of Vincent and Frances Hartgen. He grew up in rural Orono, Maine, spending his young years in the state's forests, and along its trout streams and coastlines. He graduated from Hebron Academy in Hebron, Maine, in 1962, and from Amherst College in 1966. He later earned an MA degree from Brandeis University in 1968, and a PhD from the University of Minnesota in 1976, both in American history.

He began his newspaper career while in college as an intern reporter at the Bangor Daily News in Bangor, Maine. He went on to work as a reporter and editor at The Minneapolis Star, and later at the San Diego Union and the Casper Star-Tribune as managing editor. He also taught journalism, media history and public affairs reporting at the University of Minnesota and Ohio State University.

Steve came to Twin Falls in 1982 as editor of the Times-News, working alongside then-publisher William E. Howard and general manager Richard High as Howard publications expanded across the country. By 1990, he was promoted to publisher of the Times-News.

In his years at the Times-News, Steve's leadership raised the newspaper's visibility and impact, making it one of the state's leading conservative newspapers. His common-sense and fiscally responsible editorial perspectives earned him much respect among business leaders, public officials and the community. It was during his time at the Times-News when we had the opportunity to meet and talk with Steve during our many interviews with the editorial board. We greatly enjoyed our lively visits with Steve.

Not one to be idle, Steve continued his involvement in the Magic Valley community after he left the newspaper in 2005. He became Executive Director of Business Plus, a Magic Valley economic development group, which brought hundreds of new jobs and more than \$2 billion investment dollars to the valley. The growth was so spectacular that then Governor C. L. "Butch" Otter called it the "Magic Valley Miracle."

Steve was a stalwart member of the Twin Falls County Republican Central Committee where he served as state committeeman for more than a decade, from 2008 to 2019. He also served on the Idaho Capitol Commission from 1998 to 2016, a group which oversaw the renovation and remodel of Idaho's premier public building.

In 2008, Steve was appointed to the Idaho House of Representatives by Gov. Otter where he served until 2019. While in the legislature, Steve chaired the Commerce & Human Resources Committee. He retired from the legislature for health reasons at the end of 2018 and was replaced by his wife Rep. Linda Wright Hartgen.

Following his retirement, Steve wrote extensively on the cultural history and patterns of Life in the Magic Valley and southern Idaho, publishing "Tradition & Progress: Southern Idaho's Growth Since 1990" in 2019, and "Spirit of Place: Southern Idaho Values Across Generations" in 2020. Additionally, he wrote columns for several Idaho newspapers and blog sites on southern Idaho politics and cul-

tural changes. His books and columns frequently reflected his love of the Magic Valley, which he often called the best region in the best state in the best nation on the planet.

Beyond his media work and his public service, Steve maintained an interest in western history, particularly the settlement of southern Idaho. He was also an avid fly fisherman, an outdoor activity he learned as a young man in Maine.

In his later years, Steve developed health problems, but he continued to serve in public roles and did not think of himself as disabled in any way. Steve is survived by his devoted wife Rep. Linda Wright Hartgen and his family.

While we will miss Steve's common-sense approach to public issues, fiscal policy and statewide public affairs, we will miss his friendship the most. Rest in peace, good friend, and loyal servant.

IRAN UNVEILS LONG-RANGE MISSILE AS  
VIENNA NUCLEAR TALKS RESUME

(By Parisa Hafezi)

DUBAI.—Iran unveiled a new domestically-made missile with a range of 1,450 kilometers on Wednesday, state TV reported, a day after Tehran and Washington resumed indirect talks to salvage a 2015 nuclear deal.

Iran, which has one of the biggest missile programmes in the Middle East, says its ballistic missiles have a range of up to 2,000 km (1,200 miles) and are capable of reaching its arch-foe Israel and U.S. bases in the region.

State TV displayed the new surface-to-surface "Kheibar Shekan" (Kheibar buster) missile, which refers to an ancient Jewish oasis called Kheibar in the Arabian Peninsula's Hijaz region that was overrun by Muslim warriors in the 7th century.

"This long-range missile is domestically manufactured by the Revolutionary Guards (IRGC). . . . It has high accuracy and is propelled by solid fuel and is capable of penetrating missile shields," Iranian state media reported.

Tehran regards its missile programme as an important deterrent against the United States, Israel and other adversaries. It has rejected Western demands to halt its ballistic missile work.

"Iran will continue advancing its ballistic missile programme," Iran's armed forces chief of staff Major General Mohammad Bagheri told a ceremony at an IRGC base



where the new missile was displayed, Iranian media reported.

H.R. 5633—DEPARTMENT OF HOMELAND SECURITY INSPECTOR GENERAL TRANSPARENCY ACT

H.R. 5633 would require the Office of the Inspector General (OIG) at the Department of Homeland Security (DHS) to submit to the

Congress any reports substantiating violations of certain personnel policies and allegations of misconduct, fraud, or abuse within DHS involving members of the Senior Executive Service or political appointees. This requirement would apply to reports finalized on or after 30 days from the bill's enactment, and reports would need to be published on the OIG website. The bill also would require the OIG to include information regarding ongoing audits, inspections, and evaluations in its semiannual reports and submit an additional report on compliance to the Congress within one year. Finally, H.R. 5633 would require the Government Accountability Office (GAO) to evaluate the OIG compliance report after one year.

Based on information from the OIG, CBO expects the office would need three additional employees to conduct investigations and compile reports and two additional employees to communicate with and collect information from other DHS offices. Assuming they are hired at the beginning of fiscal year 2023, CBO estimates the cost to the OIG for these employees would be about \$5 million over the 2022-2026 period. Additionally, based on the cost of similar activities, CBO estimates the cost to GAO of producing its evaluation would be less than \$500,000 over the 2022-2026 period. All such spending would be subject to the availability of appropriated funds.

The CBO staff contact for this estimate is Lindsay Wylie. The estimate was reviewed by Leo Lex, Deputy Director of Budget Analysis.
