- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.
Explain: **Four wetlands identified in the 137 acre review area were reported as isolated. These include Wetland 2 - 0.01 acre PEM, Wetland 3 - 0.16 acre PEM, Wetland 4 - 0.25 acre PEM, and Wetland 5 - 0.71 acre PEM. Wetland 2 and 3 are located in depressions in maintained turf areas. Wetland 4 and 5 are located in depressions in agricultural fields. The four wetlands have no hydrological or ecological connection to any waters of the U.S., they are not located in any**

floodplain, and are not susceptible to interstate or foreign commerce. As such, these isolated wetlands are not waters of the U.S. Additionally, one open water storm water pond (1.49 acres) was identified in the review area. The pond was reported as a stormwater detention pond constructed in uplands. However, review of aerials and soil survey indicate that the pond, which was constructed in 2007, appears to have been partially constructed within a wetland area. Multiple years of aerials prior to 2007, show significant saturation and inundation in a farm field. Also the portion of the pond that appears to have been wetland is located in hydric soils. Therefore, the pond does not appear to have been constructed wholly in uplands. However, the apparent wetland area that existed prior, appears to have been isolated, as no streams or swales are located near the area. Additionally, the storm water pond that is currently present does not appear to connect to any stream. The county tile and storm sewer maps were reviewed, and no connection is mapped. The pond only appears to capture and retain runoff from the adjacent development. As such, the storm water detention pond is isolated and not a waters of the U.S .

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
