Explain: **Wetland 1 – 0.26 acre and Stream 1 – 364 linear feet.** Contour maps show the aquatic features, located at 37.1443698°N and -85.9697351°W, are physically isolated in the landscape. The geographical area is predominately karst and consist of isolated sinkholes and man-made drainage ditches along Interstate Highway 65. The wetland has no identifiable outlet and is fed by water runoff from the

adjacent Interstate. The stream appears to be a man-made feature designed for water runoff of the adjacent Interstate. Therefore, the aforementioned aquatic resources do not possess any surface or shallow subsurface hydrological connections to a “waters of the United States (U.S.)” They are not located in a floodplain and are not susceptible to use in interstate or foreign commerce. As such, Wetland 1 and Stream 1 are not “waters of the U.S.”

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
