

EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND:** This upland referenced on this form includes the area within the review area that is upslope of the end of jurisdiction for Walters Branch. The upland encompasses 28 acres of land. The review area contains upland vegetation and upland soils. Erosional rills and gullies are present, however no evidence of a defined bed/bank and OHWM are visible within the review area. The project location is situated atop a previously mined area with heavy disturbance.
