Four Isolated Wetlands – 0.20 acres.

Wetland A (scrub-shrub) – 0.01 acres, Wetland B (forested) – 0.01 acres, Wetland C (forested) – 0.05 acres, Wetland D (forested) – 0.13 acres. Contour maps show these wetlands to be located in an isolated depression, demonstrating that the wetlands are topographically isolated. Hamilton County GIS Flexviewer shows these wetlands are not connected to Anna Kendall Drain through the regulated drainage system. During field visit, Corps staff found no evidence of swales or outlets connecting the wetlands to any surrounding ‘waters of the U.S.’ Therefore, these wetlands do not possess any surface or subsurface hydrological connection to a waters of the U.S., are not located adjacent to any waters of the U.S., are not located in a floodplain, do not possess any ecological connection, do not capture or divert any waters of the U.S., and are not susceptible to use in interstate or foreign commerce. As such, these isolated wetland are not waters of the U.S.

Two Ponds – 0.19 acres.

Pond 1 – 0.04 acres, Pond 2 – 0.15.

Contour maps show these ponds are not connected to Anna Kendall Drain, demonstrating that they are topographically isolated.

Therefore, these ponds do not possess any surface or subsurface hydrological connection to a waters of the U.S., are not located adjacent to any waters of the U.S., are not located in a floodplain, do not possess any ecological connection, do not capture or divert any waters of the U.S., and are not susceptible to use in interstate or foreign commerce. As such, these ponds are not waters of the U.S.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
