Summarize overall biological, chemical and physical functions being performed: As part of their biological functions, these wetlands support plant diversity, primary productivity, and resting, foraging, and nesting habitat for many bird, mammal, reptile, amphibian, and invertebrate species. As part of their chemical and physical functions, these wetlands store storm water and release it slowly; slow the velocity of storm water; facilitate groundwater recharge; trap sediments; and control pollution.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Aerial maps, Corps staff observations, and property owner eye-witness accounts revealed that a significant nexus exists between Wetland 1 and Yeager Finley Manard Ditch (RPW), and the White River (TNW), through a direct hydrologic connection. During the field visit, Corps staff observed Field Tile 1 (clay tile recently replaced with plastic pipe) to run directly from Wetland 1 to Yeager Finley Manard Ditch (RPW), draining the Wetland 1 area for several years. Wetland 1 is located outside the Yeager Finley Manard Ditch floodplain and is not located within NRCS Mapped hydric soils, however, Mr. David Hart stated that a natural spring does flow into Wetland 1. Ground-water flow combined with overland flow from the north and east results in regular inundation of the Wetland 1 area (NWI & FEMA Maps show flow evidence).

To conclude, Corps staff observed Field Tile 1 to run directly from Wetland 1 to Yeager Finley Manard Ditch (off-site RPW), which flows north into Pipe Creek, which flows into the White River (TNW). [Refer to Field Visit Photos #1 thru #13]

Aerial maps, Corps staff observations, and property owner eye-witness accounts revealed that a significant nexus exists between Wetland 2 and Yeager Finley Manard Ditch (RPW), and the White River (TNW), through a direct hydrologic connection. During the field visit, Corps staff observed Field Tile 2 (clay tile recently replaced with plastic pipe) to lead directly from Wetland 2 to Field Tile 1, which then leads directly to Yeager Finley Manard Ditch (RPW). Corps staff also observed Field Tile 3 leading east from Wetland 2, running south and then west along the property line, under CR 825, and emptying into Yeager Finley Manard Ditch (RPW). Both Field Tiles 2 & 3 have drained the Wetland 2 area for several years. Wetland 2 is located outside the Yeager Finley Manard Ditch floodplain and is not located within NRCS Mapped hydric soils, however, Mr. David Hart stated that the natural spring also flows into Wetland 2. Ground-water flow combined with overland flow from the north and east have resulted in regular inundation of the Wetland 2 area (NWI & FEMA Maps show flow evidence).

To conclude, Corps staff observed both Field Tiles 2 & 3 draining Wetland 2, serving as significant nexus and hydrological connection to Yeager Finley Manard Ditch (off-site RPW), which flows north into Pipe Creek, which flows into the White River (TNW).

As part of their chemical and physical functions, these wetlands store storm water and release it slowly; slow the velocity of storm water; facilitate groundwater recharge; trap sediments; and control pollution. These functions have more than a speculative or insubstantial effect on the chemical, physical and biological integrity of the White River.
