**Wetland 4 (emergent) – 0.13 acres.**

The review area for this Approved Jurisdictional Determination is 0.30 acres, and includes only the area west of Union Street and south of 161<sup>st</sup> Street that contains Wetland 4 (see Map of AJD Review Area on page 8 of this form). The Hamilton County GIS Flexviewer shows that Wetland 4 is not connected to any surrounding ‘waters of the U.S.’ through field tiles or a sub-surface regulated drainage system. Historical aerial maps show that, due to construction of the US 31 & 161<sup>st</sup> Street roundabout in 2013, the review area was re-graded and a drainage pipe was installed beneath 161<sup>st</sup> Street, however, no man-made storm-water drainage ditch was created along the south-side of 161<sup>st</sup> Street. During the field visit, Corps staff observed that the 161<sup>st</sup> Street drainage pipe re-directs storm water run-off from the roundabout towards the south-side of 161<sup>st</sup> Street, supplying hydrology to the Wetland 4 area. Although the wetland is located in upland soils, construction of a parking lot at the east end of Wetland 4 (which inadvertently serves as a dam) combined with re-grading of the area created an isolated depression, causing Wetland 4 to develop as a topographically isolated wetland. A drainage pipe is present at the east end of Wetland 4, attempting to drain the Wetland 4 area and route storm-water beneath the parking lot, however, this pipe appears to be too narrow and/or filled with sediment. Corps staff observed this pipe to empty out onto an upland area on the east side of the parking lot, and confirmed that there is no surface connection (no field swales, no ditches and no outlets) between Wetland 4 and the wetland areas on the east side of Union Street, nor to any surrounding ‘waters of the U.S.’ (See ‘7.24.2018 Pre-App Meeting Photos’ in O drive). Therefore, Wetland 4 does not possess any surface or subsurface hydrological connection to a waters of the U.S., is not located adjacent to any waters of the U.S., is not located in a floodplain, does not possess any ecological connection, does not capture or divert any waters of the U.S., and is not susceptible to use in interstate or foreign commerce. As such, this isolated wetland is not a ‘waters of the U.S.’

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
