- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.

Explain: Seven isolated wetlands totaling 1.78 acres were identified on a 10 acre parcel of land located at 7409 Fegenbush Lane Louisville Kentucky. A delineation was conducted, most recently, on August 16, 2018 by Redwing Ecological Services Inc., and was received by the Corps for review on September 5, 2018. The proposed project area is situated in an area of heavy urbanization consisting of residential and commercial development. Wetlands identified within the project boundaries consist of a combination of emergent and forested components. Contour maps show the aquatic features are physically isolated in the landscape and consist mainly of closed depressions and natural low-lying areas within the project boundaries. Direct precipitation and adjacent surface runoff appear to provide the primary source of hydrology. Based on submitted documentation, aerial imagery, and a site visit by Corps representatives, primary drainage of the property is located north and west of the proposed project site. A drainage path was identified during the site visit, July 19, 2018, that ran behind private residence located on Layman Drive to the west of the project area. The identified path proceeded north-west until the natural drainage path reached a wood privacy fence separating Layman Drive from Stovall Place (a multi-family patio home development). From the wood fence the drainage path transitions to a concrete lined ditch and flows into the subsurface storm water management system becoming untraceable without chemical means, the wetland has no additional identifiable outlet. Therefore, the aforementioned aquatic resources do not possess any identifiable surface or shallow subsurface hydrological connections to a “waters of the United States (U.S).” They are not located in a floodplain and are not susceptible to use in interstate or foreign commerce. As such, identified wetlands are not “waters of the U.S.”

**C. SIGNIFICANT NEXUS DETERMINATION**

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent**

wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
