This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The area is a bermed impoundment constructed as a safety measure for spill containment. Historically, the impoundment contained an above-ground storage tank used for petroleum products. The tank has since been removed, although the berm remains, as does the non-native substrate which consists of compacted gravel/rock that was installed at the time of construction. For the reported data points, soil pits were attempted in several locations, all of which were found to be underlain by a compacted gravel/rock base that was unable to be excavated by hand. It was determined that areas of hydric soil were only found in conjunction with a dominance of hydrophytes which appeared to have, by accumulation of organic matter over an extended period of time, developed a hydric soil layer over the compacted gravel/rock layer. As all three wetlands are located within a constructed impoundment, it was noted that the dominant plant species, indicators of

wetland hydrology, and soil profiles were consistent among all three identified wetland areas. For this reason, the single set of data points was considered representative of the conditions observed in all three wetlands.

During the field visit, Corps staff observed no evidence of swales, ditches or outlets connecting the wetlands to any surrounding 'waters of the U.S.'. Therefore, these wetlands do not possess any surface or subsurface hydrological connection to a waters of the U.S., are not located adjacent to any waters of the U.S., are not located in a floodplain, do not possess any ecological connection, do not capture or divert any waters of the U.S., and are not susceptible to use in interstate or foreign commerce. As such, these isolated wetland are not 'waters of the U.S.'
