Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody<sup>4</sup> is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to carry pollutants or flood waters to TNWs, or to reduce the amount of pollutants or flood waters reaching a TNW?
- Does the tributary, in combination with its adjacent wetlands (if any), provide habitat and lifecycle support functions for fish and other species, such as feeding, nesting, spawning, or rearing young for species that are present in the TNW?
- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to transfer nutrients and organic carbon that support downstream foodwebs?
- Does the tributary, in combination with its adjacent wetlands (if any), have other relationships to the physical, chemical, or biological integrity of the TNW?

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Wetland A is topographically confined to the southwest corner of the review area and is constricted by a railroad to the south and CR 550 E to the west. A small CMP does appear under the road; however, the pipe does not re-emerge west of the road and it is uncertain where it drains to. A map showing the location of storm sewers does not indicate an inlet or utility in this location that could possibly serve as a connection. Wetland B lies within a topographic “bowl” that does not drain. Wetland C collects drainage

from the immediately surrounding watershed, which is ultimately impounded by the railroad to the south (no pipes or drainage structures are located anywhere under the railroad). Wetland D also collects drainage from the immediate watershed, and it is separated from Wetland C by an area of significantly higher elevation. Wetland E is a remnant of a wetland that was cleared for the installation of a Vectren pipeline (see "Wetland J" in the delineation excerpt for LRL-2016-1226). It is impounded by the higher elevation that now exists in the pipeline easement. Wetland F formed as a result of the pipeline installation blocking natural drainage to the west. Wetland F is now confined between the pipeline easement to the west, railroad to the south, and existing industrial development to the east. Wetland G is a remnant of a wetland that was impacted as a result of the pipeline installation (see "Wetland J" in the delineation excerpt for LRL-2016-1226). It is confined by the higher elevations of the pipeline easement to the west and the rise within the fencerow to the east. Wetland H lies within a topographic "bowl" and does not drain. In summary, there are no possible surface or subsurface hydrologic connections from the wetlands or pond, such as swales, drainage tiles, channels, etc., to any Waters of the U.S. (WOUS). Additionally, there are no known ecologic pathways or connections with any WOUS. Therefore, the wetlands and pond in question are isolated, not susceptible to use in interstate or foreign commerce, and are not considered WOUS.
