Explain: The review area for the JD includes <5 acres. The JD includes Jimmy Nash Pond measuring 0.84 acres that was created in uplands and an ephemeral drainage feature that drains into the pond. There is an overflow pipe in the southwest side of the pond and according to the Soil Survey of Morgan County Indiana the overflow pipe ends underground. The pond is an upland feature with no known hydrologic or ecologic connection to Waters of the U.S. and is not susceptible to use in interstate or foreign commerce. No other aquatic resources are located on the < 5 acre parcel.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: During the field visit, Corps staff observed no evidence of swales, ditches or outlets connecting the pond to any surrounding 'waters of the U.S.'. The pond was created in dry upland for the purpose of aesthetics. The pond source of water is stormwater from the adjacent residential area and was not constructed from or captures waters of the U.S.; therefore, the pond is not waters of the U.S. and not regulated under the Clean Water Act. As such, the upland pond and ephemeral drainage feature are not 'waters of the U.S.'.
