Wetland A (emergent) – 0.13 acres

Lidar imagery and contour maps show this wetland to be located in an isolated depression surrounded by levees, demonstrating that the wetland is topographically isolated. Lidar imagery, contour maps, and aerial maps show that no hydrological connection or significant nexus (via swales, ditches, or a regulated drains) exists between Wetland A and any surrounding ‘waters of the U.S.’.

On April 22, 2019, RQAW staff & Hydrological Surveyor made a second site visit to perform a more in-depth evaluation of the hydrology of Wetland A and Erosional Feature 1.

Aerial Photographs and Photos 54 & 56 (Waters Report, 5/7/2019) show a 41 foot wide man-made levee & access road separating Wetland A and Erosional Feature 1. During the site visit, RQAW staff dug 3 foot down into the southwest end of Erosional Feature 1 (Photo 56), observing that no pipes exist between Wetland A and Erosional Feature 1, and thus confirming that no drainage nor hydrological connection occurs between these two features.

Therefore, this wetland does not possess any surface or subsurface hydrological connection to any ‘waters of the U.S.’, is not located adjacent to any ‘waters of the U.S.’, does not possess any ecological connection, does not capture or divert any ‘waters of the U.S.’, and is not susceptible to use in interstate or foreign commerce. As such, isolated Wetland A is not a ‘waters of the U.S.’.

Erosional Feature 1 – 46 linear feet

Historic & current aerial maps, contour maps, and Greene County GIS show that Erosional Feature 1 is not a man-made feature, nor is it a regulated drain. Aerial Photographs & Photos 56 -61 (Waters Report, 5/7/2019) show that this erosional feature developed due to the periodic release of storm-water from the Pond 2 over-flow pumping station (Goose Pond Fish & Wildlife Area). Photos 56 -61 also show that this feature exhibits ephemeral flow and had developed entirely in an upland area. During their second site visit, RQAW staff dug 3 feet down into the southwest end of Erosional Feature 1 (Photo 56), confirming that no pipes nor hydrological connection exists between this feature and Wetland A. Therefore, Erosional Feature 1 is an ephemeral erosional feature that developed wholly in an upland area, does not capture or divert any waters of the U.S., and is not susceptible to use in interstate or foreign commerce. As such, Erosional Feature 1 is not a ‘waters of the U.S.’.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD

Substantial photo evidence coincides with wetland data, confirming that Wetlands A is indeed a wetland. Lidar imagery, topographical map, and current & historical aerial maps coincide with photo evidence, confirming the absences of hydrological connection or significant nexus (via swales, ditches, or a regulated drains) between any surrounding ‘waters of the US’ and Wetlands A, and proving beyond speculation that this wetland is isolated. On April 22, 2019, RQAW staff & Hydrological Surveyor made a second site visit to perform a more in-depth evaluation of the hydrology of Wetland A and Erosional Feature 1, therefore, an additional field visit was not necessary.
