Explain: The approx. 1,200 linear feet (lf) “Sawmill Conveyance” located south of US 40 and north of Pency Trail (abandoned railroad) was constructed in 2004 within dry land for the purpose of providing a stormwater drainage outlet for the Sawmill Neighborhood north of US 40 that was constructed at approximately the same time (see 2004-2005 Google Earth aerials). The outlet under Pency Trail was not constructed as originally designed and backs up water in the ditch and surrounding property (see as-built plans and electronic correspondence dated 4/25/2012 from Natural Resource Consulting Service). Leary Drain (approx. 2,700 lf within the review area) was constructed in 2007 (see Google Earth aerial) within dry land and is located along the south side of Pency Trail. It captures stormwater runoff from the city of Greenfield and carries it west into a constructed stormwater basin where it outlets into Wilson Ditch (the outlet was

authorized under Corps ID No. LRL-2007-553). Both ditches are used solely for the purpose of capturing upland stormwater and runoff. The features were not constructed from or captures a water of the U.S.; therefore, the ditches and associated basin are not waters of the U.S. and not regulated under the Clean Water Act.

If the waterbody<sup>4</sup> is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to carry pollutants or flood waters to TNWs, or to reduce the amount of pollutants or flood waters reaching a TNW?
