B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND: This jurisdictional determination covers approximately 2.2 acres of the Andy Blair Property. The review area contains upland vegetation and upland soils with no evidence of defined bed, banks, or OHWMs. The project area did not contain any waters of the U.S. and would not be regulated under section 404 of the Clean Water Act.
