Additional comments to support AJD:** The review area has been extensively disturbed through clearing, grading, and draining of the existing pond during construction of the adjacent residential development. A preliminary jurisdictional determination was completed January 13, 2017 for the entire 170-acre site. The review area for this AJD is an approximately 3-acre area on the southeast edge of the site.
